Whereas: During his years with the State of Hawaii's radiation control program, Russ has been a strong supporter of the CRCPD. He has been a Director Member since 1991 and an Associate Member from 1989 to 1991; and

Whereas: In his support of the goals and objectives of the CRCPD, Russ has served the organization in a number of ways, including:

- > Serving as an Advisor to Homeland Security/Emergency Response Emerging Issues Committee;
- > Serving as an Advisor to Homeland Security/Emergency Response (HS/ER) 4: Task Force for Operational Guideline Models and Tools for Recommendations and Responses to RDD/IND;
- Serving as an Interactive Working Group Resource to H 25 Task Force for Intensity-Modulated Radiation Therapy (IMRT);
- Serving as an Interactive Working Group Resource to H 32:
 Committee on Computed Tomography; and
- Serving as an Interactive Working Group Resource to Suggested Regulations - Part Z: Medical Credentialing.

Whereas: In recognition of his outstanding work with the CRCPD, Russ received several honors, including:

- > Several Board of Directors Outstanding Achievement Awards for his contributions on several CRCPD working groups; and
- > The Gerald S. Parker Award, CRCPD's highest award, in 2009.

Whereas: Russ' dedication and self-sacrifice to his chosen profession have earned him the right to a deserved and pleasant retirement.
