BOARD OF DIRECTORS RESOLUTION

Relating to: Debra McBaugh's contributions to radiation protection and in particular, her many significant contributions to the Conference of Radiation Control Program Directors, Inc. (CRCPD)

Whereas: Debra McBaugh, CHP, has given 22 years of professional service to the State of Washington in the Office of Radiation Protection of Department of Health, where she has served in many positions and has been a Section Manager since 1996, the latest of which was over the Radioactive Materials Section;

Whereas: Debra was elected to the National Council on Radiation Protection and Measurements, where she is serving on the NCRP Board of Directors, and has been distinguished as a Fellow Member by the Health Physics Society;

Whereas: During her years with the State of Washington's radiation control program, Debra has been a strong supporter of the CRCPD and Associate Member since 1989; and

Whereas: In her support of the goals and objectives of the CRCPD, Debra has served the organization in a number of ways, including:

- Serving as Chair-Elect of CRCPD in 2004-2005; as CRCPD Chairperson in 2005-2006; and as Past Chair in 2006-2007;
- Serving as member and Chair of the Committee on Decontamination and Decommissioning from 1997-2001;
- Serving as Chair of the HS/ER-1 Task Force for EPA's Creation of National Monitoring System from 2004-2010;
- Serving as Chair of the HS/ER-4 Task Force for Operational Guidelines Models and Tools for Recommendations and Responses to RDD/IND; and
- CRCPD representative on several NRC working groups.

Whereas: In recognition of her outstanding work with the CRCPD, Debra received several honors, including:

- Several Board of Directors Outstanding Achievement Awards for her contributions on several CRCPD working groups; and
- The James W. Miller Award in 2004 for her major role in preparing Washington State for TOPOFF 2, a national radiological terrorism exercise, leading a group that developed predetermined protective action recommendations.

Whereas: Debra's dedication and self-sacrifice to her chosen profession have earned her the right to a deserved and pleasant retirement.

Now Therefore, Be It Resolved:

That Debra McBaugh, CHP, is hereby recognized and appreciated for her many years of service to CRCPD, a service that benefits all citizens in the United States to a freedom from unnecessary radiation exposure, and as such is worthy of and hereby granted "Life Membership" in the CRCPD; and
