Charges:

1. To consult, comment and make appropriate recommendations concerning TENORM issues and regulatory revisions to the SR-N Committee, as appropriate.
2. To review and provide a report to the CRCPD Board on the following recommendations from the *E-42 Task Force Report Review of TENORM in Oil and Gas Industry*.
 Assess and determine if the definition of TENORM as identified SR-N should be revised or changes as discussed in the E-42 Task Force Report. This will be completed with one year after Committee activities begin.
 Review the training recommendations identified in the Task Force Report and identify training components to be implemented by SR-N.
 Prepare a consolidated guidance document for the non-licensing nature for TENORM facilities. This guidance should be in the format of the USNRC NUREG-1556 series.
 Evaluate the feasibility of CRCPD maintaining a compendium of state regulations and guidelines pertaining to the regulatory management of TENORM.
 The discussions and reports related to these charges will not be limited to just oil and gas industry, but will also evaluate other TENORM production processes. Industry stakeholders, consultants, and representatives of other professional organization should be included in the completion of this charge.
3. To inform the CRCPD Board of emerging issues related to the regulation of TENORM.
4. To provide the CRCPD Board, at least annually, a report on activities, successes and possible emerging issues.
5. To liaison with the Interstate Oil and Gas Compact Commission (IOGCC).
