3. To develop a “white paper” exploring “Defense-in-Depth” for low level radioactive waste (LLRW) disposal sites.
4. Review and update the CRCPD report entitled “Environmental Monitoring Report for Commercial Low-Level Radioactive Waste Sites (1960’s through early 1990’s), November 1996, DOE/LLW-241.”
