Charges:

1. Determine the elements of diagnostic x-ray technique that impact image quality and patient exposure in adult and pediatric exams to aid facilities in maintaining minimal patient exposure and consistent high quality diagnostic images. [G1 - O3, O4, O5] [G2 - O2] [G3 - O3, O4]
2. Recommend and develop information useful to states in implementing a quality assurance program for diagnostic x-ray facilities. [G1 - O3, O4, O5] [G2 - O2] [G3 - O3, O4]
3. Review and update collectibles for appropriateness for the CRCPD webpage and perform this review at least every five years. [G1 - O3, O4, O5] [G2 - O2]
4. To develop training and inspection protocols on diagnostic x-ray for state inspectors in conjunction with the G-55 Training Committee.
5. To coordinate activities and reports for Liaisons to AAPM, ACR, ARRT/ASRT, and the Joint Commission.
