# **Duration**

**29 months maximum** (24 months for learning delivery plus 5 months for End Point Assessment)

# Qualifications

Level 6 Apprenticeship (equivalent educational level: Bachelor's Degree) plus Chartered Trading Standards Practitioner (CTSP) status from the Chartered

**Trading Standards Institute.** As well as the mandatory Tobacco & Vapes module, learners also have the opportunity to choose another specialism to study from Food Standards\*, Animal Feed\*, Animal Health & Welfare, Weights & Measures\*\*, or Product Safety and become competent in enforcement in those areas.

\*Option to transition to FSA certification via a CTSI oral exam and successful coursework assessment.

\*\*Designed as an introduction to Weights & Measures. Learners can opt for additional study with the CTSI for the Section 73 Certificate to become a qualified Weights & Measures Inspector.

# Programme Overview

CSA Learning is proud to be supporting the Government's initiative to stop harmful tobacco and vape products finding their way into neighbourhood shops and stopping underage sales. The Tobacco and Vapes Bill 2024-25, if enacted, would create the first "smoke-free generation" by ensuring children born on or after 1 January 2009 can never be legally sold tobacco.

The bill includes other provisions which focus on making vaping less attractive and accessible to children and young people, strengthening smoke-free restrictions, and strengthening enforcement around the sale of tobacco and vaping products. In summary, the bill contains provisions:

- on the supply of tobacco, vapes and other products, including prohibiting the sale of tobacco to people born on or after 1 January 2009
- on the licensing of retail sales and the registration of retailers
- to enable product and information requirements to be imposed in connection with tobacco, vapes and other products
- to control the advertising and promotion of tobacco, vapes and other products, and;
- on smoke-free places, vape-free places and heated tobacco-free places.

In collaboration with Trading Standards partners we have built a bespoke training programme to provide specialist training for the Trading Standards sector starting with 80 designated local authorities. Our aim is to develop a highly skilled team of enforcement officers to support the drive to make our communities a safer place.

We will be delivering this Level 6 Trading Standards Professional apprenticeship programme via a series of online Workshops over a shorter, more intensive period of no longer than 29 months (including End Point Assessment) and incorporating the new Tobacco & Vape legislation into a specialist module that all apprentices will undertake. We have altered the running order of the current Level 6 Trading Standards modules to enable Trading Standards teams to deploy competent officers earlier in the programme.

The new programme will require the learners to undertake the new Tobacco and Vapes specialist module as well as one other from the standard list (Weights & Measures, Feed, Food, Product Safety, Animal Health and Welfare).

# Learner profile

The Department of Health and Social Care (DHSC), as the funding body, has specified that use of the funding provided to Local Authorities is for new apprentices only onto the three-year Level 6 programme. These apprentices must be new recruits and not existing staff transferred over from another course. These apprentices should also be new to the profession, with no prior associated qualifications (Regulatory Compliance Officer or CTSI Stage 1), and be specifically recruited to the role.

# **Enrolling**

Once your new apprentice Trading Standards Officer is in post you will be able to reserve a place on one of the eight cohorts that will be launching between July and October 2025.
