After I left full time pharmacy practice in emergency medicine, I still felt I had something to give. I have been deployed via DMAT and CAL-MAT but I wanted to do something closer to home. CSHP offered us the opportunity to get our Immunization Certification. This is a great chance for the those of us who missed previous opportunities. With the promise of COVID vaccines on the horizon and knowing the the first tier would be healthcare workers and those in nursing homes, I took the course.

I joined the CVS team that goes out to facilities to vaccinate both the staff and the residents. For those residents at the SNF level, we go directly to their rooms after we review their consent and screening questions. We also take the opportunity to review their medication profile. For those residents in either assisted living or independent living, the facility arranges a socially distanced central area for the screening.



vaccination and the observation period. I work with a wonderful team of both pharmacists and technicians. Two of the technicians have become certified immunizers.

I have attached a photo of a pharmacy technician (Anna Wilson) and myself working in PPE at a SNF. Working as a team, we are able to quickly and safely vaccinate the residents. Despite all the news of vaccine hesitancy, we have very few refusals. We have traveled to a wide variety of facilities from small residential care homes to very large multilevel complexes.

I found this to be a wonderful opportunity to be involved in direct patient care.
