Member Spotlight



My Involvement with the COVID-19 Vaccination Efforts Written by: Lisa Kroon, PharmD, FCSHP, FAPhA, CDCES

Since the start of the pandemic, the UCSF School of Pharmacy leadership took the stance that pharmacy students are considered essential to the health care mission and essential to the health care response to the COVID-19 pandemic. In anticipation of student involvement in the COVID-19 vaccination effort, all first year pharmacy students completed immunization training in-person--this was one of the only times we brought our students to campus for in-person instruction in 2020. Our pharmacy students, like many pharmacy students, have participated in COVID-19 vaccination efforts across California. The UCSF School of Pharmacy, in partnership



with UCSF Health Pharmacy Enterprise, offered pharmacy learners and faculty to not only serve as immunizers, but importantly, to support the pharmacy operations for vaccine preparation. To ensure consistent participation, I worked closely with our experiential faculty to incorporate the vaccine clinic support into existing IPPE and APPE rotations, rather than creating an elective experience. Similarly, the COVID-19 clinic support was integrated into rotations of the UCSF pharmacy residents. To date, more than 225 students and all of our residents have participated in the UCSF COVID-19 clinics.

Many of our volunteer faculty across the state expressed their desire to be immunization trained to support the COVID-19 vaccination efforts. Therefore, to expand the pool of pharmacist vaccinators, our faculty, led by Dr. Valerie Clinard, offered and conducted two virtual immunization trainings (in December 2020 and March 2021) and the in-person skills practicum for over 80 pharmacists, including many of our volunteer faculty across California. It was a real team effort to train pharmacists virtually and then coordinate the inperson practicum. UCSF sent kits of syringes, cotton balls, and saline to each pharmacist. The pharmacists were then evaluated by immunization certified pharmacists at their local

practice sites. As a gesture of our gratitude for their work, we provided the trainings as part of our preceptor and professional development program. I am very proud of this effort-by creating more certified pharmacist immunizers, these pharmacists can now serve as additional trainers and preceptors for student immunizers not just for the COVID-19 vaccine campaign but future public health initiatives.

As I reflect on my career journey to date, CSHP has certainly been a large part of it. Being a member since I was a pharmacy resident at UCSF, I have had the opportunity to serve on many CSHP committees/task forces and serve in roles locally with the Golden Gate Chapter. We are fortunate to have a state pharmacy society that continually works to advance the profession—with the tremendous volunteer efforts of many dedicated members. I can't wait to be able to get together in person again to catch up with my CSHP friends!


