Some specific areas to consider could include:

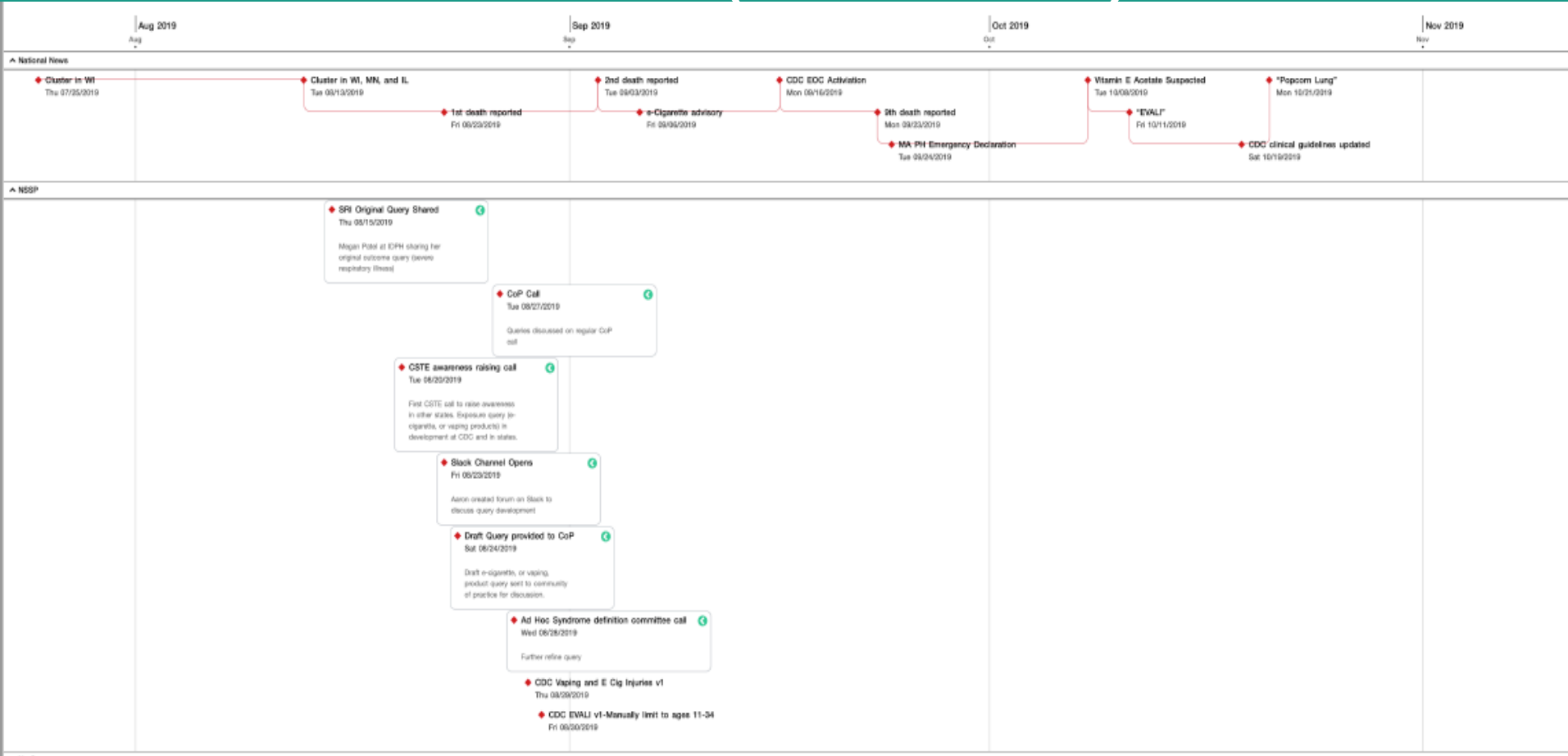
1. How did you feel that the Vaping/EVALI query development process went?

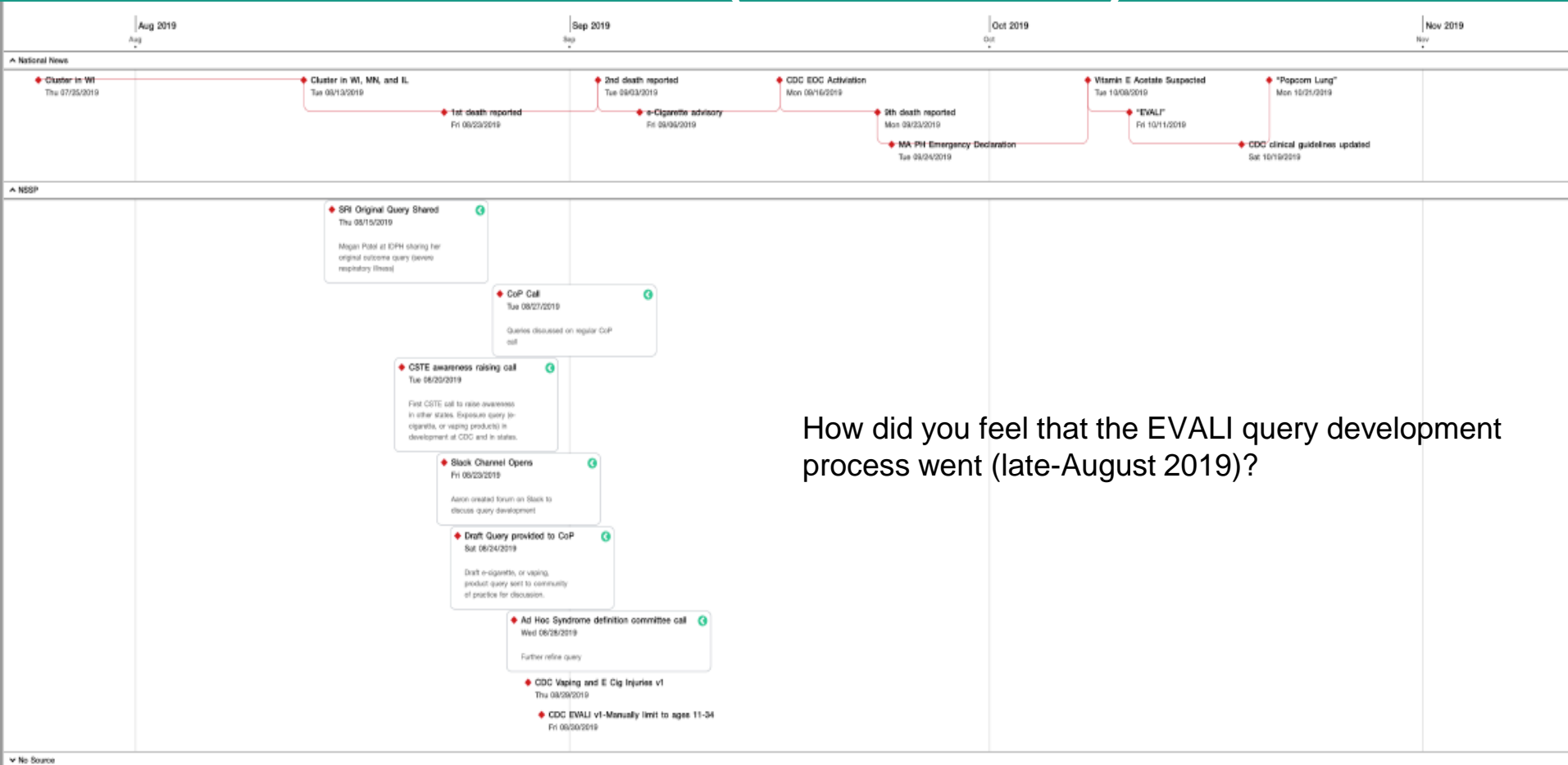

How did you feel that the EVALI query development process went (late-August 2019)?

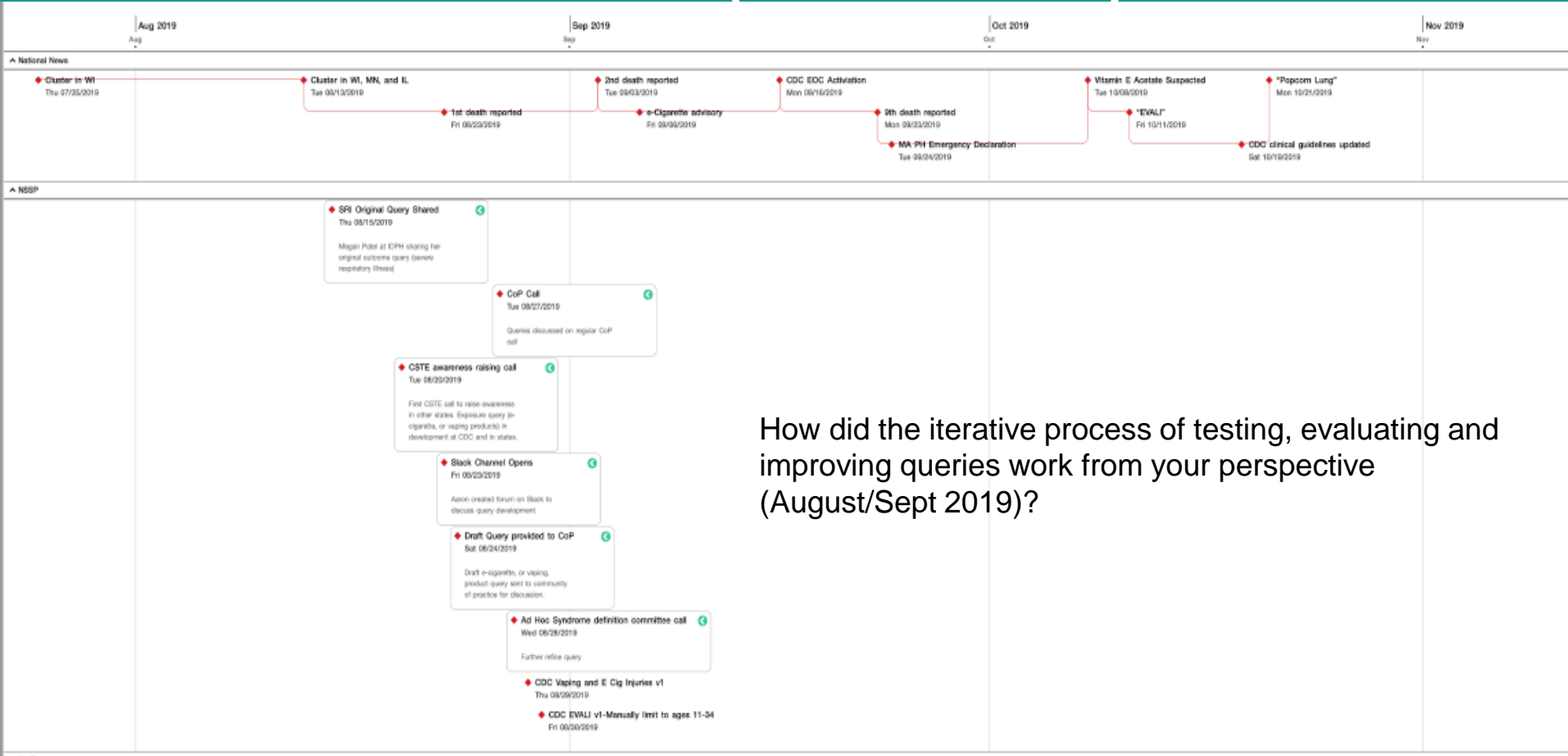

How did the iterative process of testing, evaluating and improving queries work from your perspective (August/ Sept 2019)?

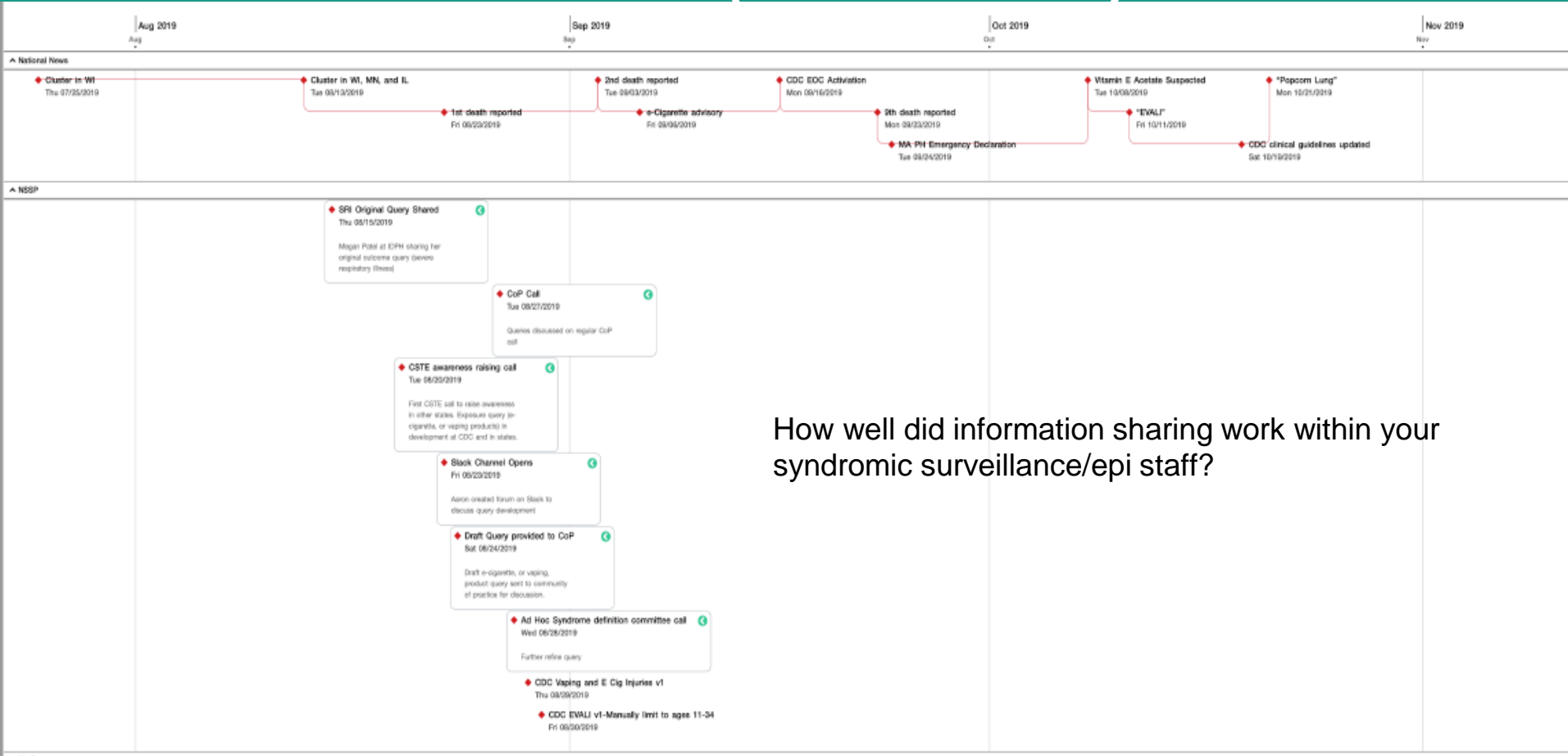

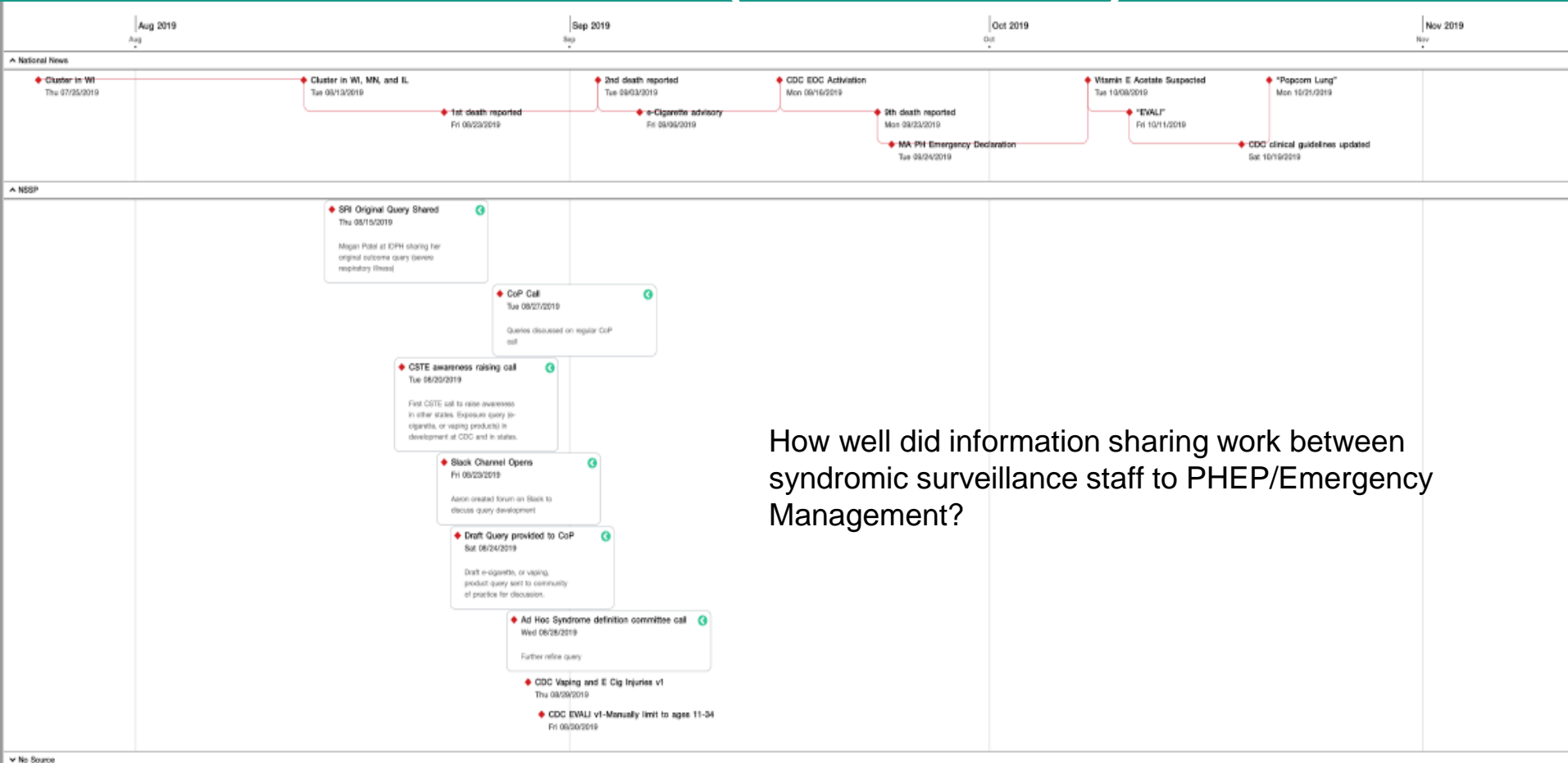

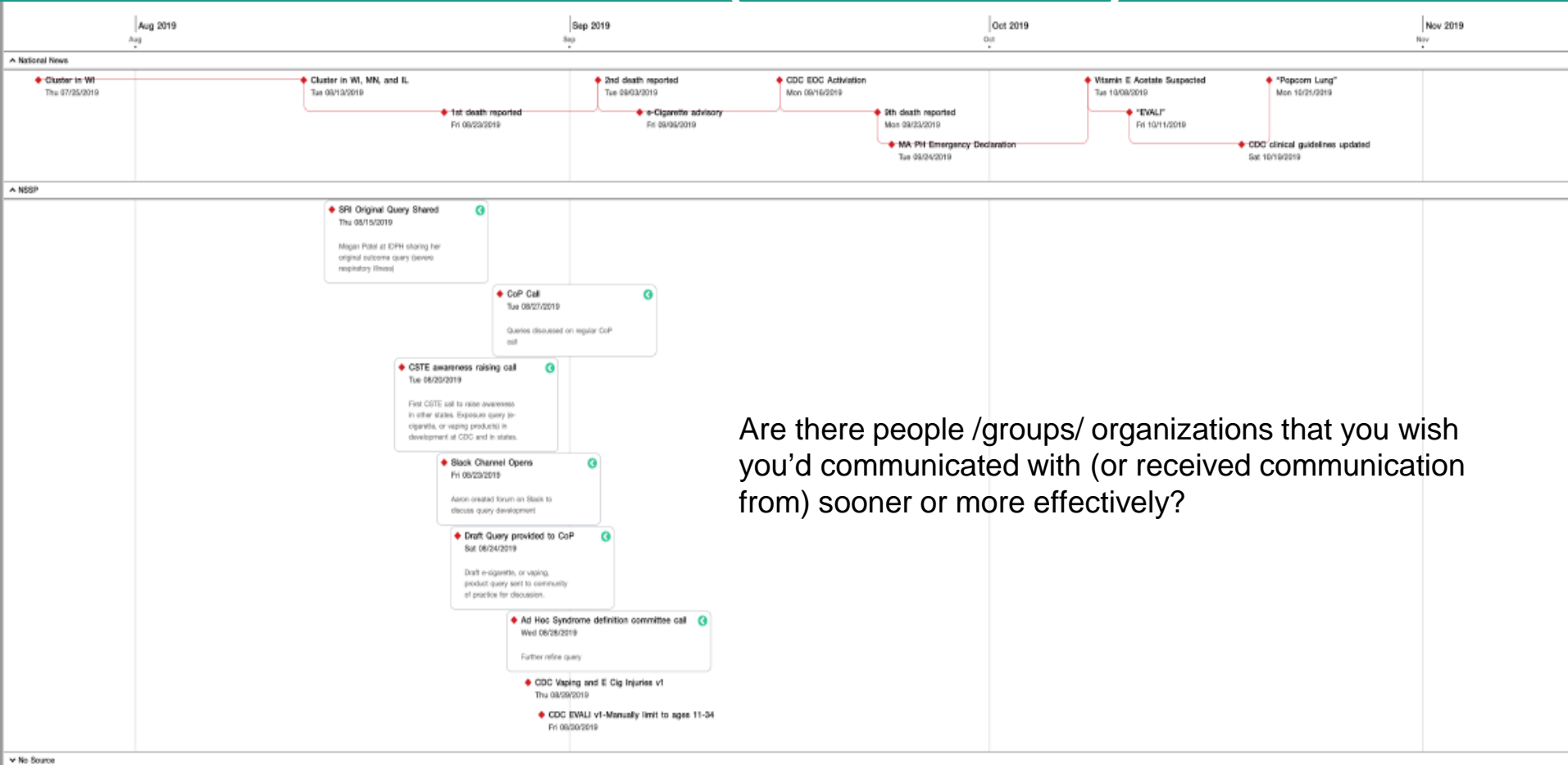
