1) **COPYRIGHT ASSIGNMENT.** As a condition of publication, and in light of the Illinois MCLE credit offered by the Illinois Supreme Court for authoring substantive legal articles for publication, \_\_\_\_\_, the "Author," hereby assigns, and transfers to the DuPage County Bar Association, the "DCBA," its successors and assigns, the entire right, title and interest in and to the copyright in the Article and any registrations and copyright applications relating thereto and any renewals and extensions thereof, and in and to all works based upon, derived from, or incorporating the Article, and in and to all income, royalties, damages, claims and payments now or hereafter due or payable with respect thereto, and in and to all causes of action, either in law or in equity for past, present, or future infringement based on the copyrights, and in and to all rights corresponding to the foregoing throughout the world. Should the DCBA Editorial Board decline to publish the Article, the Copyright shall revert back to the Author.

2) **LIMITED LICENSE OF REPUBLICATION TO AUTHOR.** As owner of the copyright of the Article, following the initial publication of the Article in the DCBA Brief, the DCBA grants to Author a non-exclusive, worldwide, perpetual irrevocable, royalty-free, sub-licensable, and assignable right and license to use, republish, reprint, and distribute the Article through any means of expression including electronic format, provided that the Author (and any subsequent holder of a license or sublicense granted pursuant to this paragraph) agrees not to publish the Article prior to its initial publication in the Brief Magazine and the Author agrees to credit the Article's original publication by the DCBA Brief magazine in a tagline or some similar means.

Author shall indemnify and hold harmless the DCBA, its officers, directors, agents, employees, and sponsors against any claims to the contrary as defined in this paragraph.

5) **DCBA BRIEF MAGAZINE EDITORIAL RIGHTS.** Author acknowledges that the DCBA, as the copyright owner of the Article under this Assignment, has the right to: A) edit the Article, including the title, or decline to publish, in its discretion or at the discretion of the Editor of the Editorial Board of the DCBA; B) authorize republication of the article in the DCBA Brief (the official publication of the DCBA), or in any other publication requesting reprint/republication permission; and C) authorize derivative works based upon or including the Article (in any media now known or created in the future).
