Grant funds not used or committed by that time shall be deemed unspent. Any funds paid to the grantee and not fully used within the one year period shall be returned to DBF. It shall be the responsibility of the applicant to provide proof of compliance with this policy before any other applications for funds will be considered. Waiver of this policy may be made by the DBF Board of Directors upon good cause shown.

All grant funds must be used for the purpose(s) stated by the applicant in the Grant Application. When a grant of \$5,000 or more is awarded, the funds will be paid in two equal shares over the term of the project upon proof that it is ongoing and that the DBF funds are being used or have been committed for the stated purpose(s). It shall be applicant's obligation to provide the required information in support of its request for the second installment payment.
