Call to Order The President Dr. Ruple Galani, called a meeting of the Duval County Medical

Consent Agenda Dr. Ruple Galani asked the Board for a motion to approve the items under the

Consent Agenda. A motion was made and seconded to approve the Consent

Agenda as submitted.

MOTION 01-10-18 MOTION PASSED TO APPROVE CONSENT AGENDA, CONTAINING THE MINUTES

(08/07/18), SECRETARY'S REPORT (10/02/18), YTD MEMBERSHIP REPORT

(10/02/18), AND TREASURER'S REPORT (08/31/18) AS SUBMITTED.

Foundation Report Dr. Sunil Joshi presented the Foundation Report. He highlighted the LifeBridge

Physician Wellness Program, which has currently assisted 16 member physicians

to date.

He also reported that after much discussion between the DCMS Foundation

Board of Directors and the DCMS Executive Committee, it has been

recommended that the DCMS Annual Meeting and DCMSF Future of Healthcare Conference be combined into one event in 2019. Due to the high amount of DCMS staff time dedicated to the conference and the lack of sponsors able to contribute to the Annual Meeting after giving to the Future of Healthcare Conference, the combining of events is the best option for both entities. In the future, when the Foundation has its own staff that can coordinate the conference, splitting the events back into two may be considered.

Dr. Joshi informed the Board that the combined event will be under the Foundation, however, after the event the Foundation will pay the DCMS \$20,000, the budgeted net income the DCMS generates each year. After each yearly meeting, a committee will meet to analyze the financials and, if applicable based on that year's income, will pay out more to the DCMS. Discussion ensued and concerns were discussed. Though the date of the 2019 combined event is unknown, it will be at a time when the AMA President- Elect can attend. A motion was made to agree to a joint meeting on a date to be determined later. The motion was seconded.

It was noted that each member of the Executive Committee, with the exception of Dr. Galani, indicated they would be unable to commit to a DCMS Presidency in 2019. According to the bylaws, the Executive Committee has decided to appoint current DCMS President, Dr. Ruple Galani, to also serve as President-elect. The Board of Directors and Ex-Officios present then discussed the unique situation the DCMS is in, why no others can take on the President- Elect position at this time, and the understanding amongst the Executive Committee that this should not happen again.

A motion to approve the amended recommendation from the Executive Committee was made. The motion carries.

2019 DCMS Budget- Dr. Ruple Galani presented a PowerPoint, which included a detailed account of the Annual Budget Process. He presented Revenue and Expenses for 2018, a Budget Review since 2013, a Projected Final Budget for 2018, and the proposed 2019 Budget. Dr. Galani noted that 72% of income is membership dues, therefore all Board members should be actively recruiting physicians into the society. Mr. Bryan Campbell then explained that though the budget review looks like yearly income is decreasing, it only looks that way because the DCMS is no longer calculating in an administration fee from the Foundation. It was noted that the society's accounting firm, BDO, underestimated payroll tax when creating the 2018 budget. Dr. Galani and Mr. Campbell completed the presentation with a 2019 budget surplus of \$4,010.

A motion was made and seconded to approve the recommended 2019 DCMS budget as presented.

CEO Report

Mr. Bryan Campbell told the Board that the Jacksonville Veterinary Society recently had a suicide in their group. Mr. Campbell and Dr. Joshi encouraged all Board members to try a session of the LifeBridge DCMS Physician Wellness Program to not only see how the program is run, but to be able to make a personal recommendation to physicians in need.

Mr. Campbell has been working on a \$20,000 endorsed partnership with St. Johns Asset Management. After discussion, the Board of Directors agreed that this partnership should be pursued.
