# DEFENSE COUNCIL BOARD MEETS, HOLDS ANNUAL PLANNING SESSION

The DCUC Board of Directors held its regular meeting and annual planning session on November 4th and 5th, 2004, at the Grand Hyatt Hotel in Tampa, FL.

The treasurer's report and financial statements for the period ending September 30, 2004, were reviewed and approved

Roland "Arty" Arteaga, President/CEO, briefed the Board on the State of AFFN. Arty also reported on the State of the Council, the status of the GEM Fund, and other ongoing actions. He presented his proposed 2005 DCUC Budget, which was unanimously approved by the Board.

At the Planning Session, the 2004 Conference was reviewed. It was announced that there was a total attendance of 218 and that the feedback — verbal and written — was excellent.

The 2005 Conference, which will be held in Charleston, SC, August 21 - 24 at Charleston Place, was previewed. Registration fees will remain at \$650 for early bird registration. As in the past, there will be various optional tours, plus the annual Vince Lascara golf tournament. Fees for these events are yet to be determined.

It was announced that the format would remain generally the same as the 2004 Conference except that the schedule will revert back to pre-Las Vegas with golf on Saturday and military breakouts and Chairman's Reception on Sunday.

The Board approved the dates of August 20 – 23 for the 2006 conference to be held in New Orleans, LA.

Mr. Arteaga presented his 2005 Business Plan, which was approved.

### DoD — DID YOU KNOW

...that some of our troops' debit/credit cards are being compromised in Iraq and resulting in fraud. According to a recent message received from the Army, account data is retrieved from Data Terminals used to swipe debit cards at in-theatre post exchanges. The data retrieved is then copied to blank credit cards and used to freely access the individual's checking account. In one case, an individual used his debit card at the Exchange in Fallujah and had his card duplicated. Unauthorized withdrawals took place over a thirty-day period and on October 31st the victim noted his account was at a zero balance. What say we get the word out to our troops on Identity Theft and Credit Card Fraud, especially as they prepare to deploy in support of Operation Iraqi Freedom. ## Why I Serve:

### Marine Recruit Learns Discipline, Leadership Lessons

"I wasn't disciplined enough for college," said Marine Corps recruit Joseph E. Solinger.

The 19-year-old Columbus, Ohio, native said he realized in high school about a year ago that his self-indulgence and spotty grades were taking him nowhere. He said his attitude and study habits were exceptionally poor.

After talking things over with his father, a former Marine officer, Solinger elected to join the Marines' Delayed Entry Program in October 2003.

Fast-forward to today. After completing 12 weeks of intensive training, the young recruit was slated to graduate on Nov. 5 and become Pfc. Solinger, U.S. Marine.

The Marine Corps, Solinger discov-

ered, is "the place to get discipline and to work on my leadership skills."

Assigned to H Company, 2nd Recruit Training Battalion, Solinger learned his lessons well at Parris Island. He was selected as an honor recruit for his leadership, attention to detail, and other skills.

As a soon-to-be Marine, Solinger said he gained new perspectives on how people from different backgrounds can cooperate to accomplish difficult tasks. His Parris Island experiences, he said, also taught him "how to work with people from all over the country."

And, embracing teamwork "is essential" to becoming a Marine, he said. "There's not one recruit that can make it through recruit training," Solinger said, "without the help of another recruit."

Joining the Marine Corps, he observed, would be a good decision for

many of today's young people who "are walking around in sloppy clothes."

The Marines, he explained, extol responsibility, good personal hygiene, manners, and proper posture.

Recruits who seemed to lack self-confidence and direction when they arrived at Parris Island, Solinger observed, are transformed by Marine training to embrace self-discipline and responsibility.

And discipline, he noted, "is something that you need in life."

# NAVY FCU PENSACOLA CALL CENTER IS FLORIDA'S FIRST CERTIFIED COMMERCIAL "GREEN BUILDING"

Navy FCU's new state-of-the-art call center in Pensacola has become Florida's first commercial building to receive LEED (Leadership in Energy and Environmental Design) "Gold" Certification, making it a certified environmentally friendly "green building". LEED is part of the U.S. Green Building Council's Green Building Rating System™, which is a voluntary, national standard for developing high-performance, sustainable buildings. The 56,000-square-foot building is one of 25 "Gold" rated LEED projects in the United States. Designed and constructed to withstand winds up to 140 mph, the facility was undamaged by Hurricane Ivan.

The primary objective for Navy FCU's Pensacola call center was to develop an employee-focused facility while reducing capital costs, energy costs, health care

costs and increasing employee productivity and retention. The building and its grounds reflect that focus—complete with a fitness center, walking trails, dining amenities, training facilities, a "mothers" room and more.

"We created a workplace environment that promotes employee comfort and job satisfaction—a place where people will want to work for years to come," said Ebb Ebbesen, Navy FCU's project manager for the Pensacola Call Center. "The call center was truly built for our greatest assets, our employees and members."

The building's exterior was designed and constructed with local materials used to evoke a local style. The interior architecture of the building is intended to create the most productive environment possible for the employees. Call center workstations are organized to take full advantage of views and to maximize the use of daylight as a lighting source. Workstations use the Herman Miller

Resolve system, creating open, inviting, space-efficient workstations where employees feel comfortable and connected.

The main call center features a 400-foot long glass and Kalwall partition providing employees a breathtaking view of the live oaks and the pond beyond. The main call center floor is controlled by a very sophisticated lighting system including a solar shade/reflector along the window wall with automated shades, which dims the lights and raises or lowers the shades as required, eliminating glare and maintaining the optimal lighting level.

Regular meetings were held throughout the construction process to ensure the facility was being built in accordance with the plans, specifications and LEED criteria established by the Navy FCU team. "This facility is proof of our commitment and investment to this project, our employees and sustainable design," said Ebbesen.
