The Alpha Fund is used to develop and support The Order's Junior Daughter ministry. It provides financial support to senior Daughters or Junior Daughter directresses in their efforts to extend Christ's kingdom among young women and girls.

The Alpha Fund is used to begin new Junior chapters, strengthen existing ones and provide assistance for retreats, service projects, and activities.

Requirements

In addition to this form, Alpha Fund grant applicants must submit all of the following as a single application packet:

1. On a separate sheet of paper, provide a detailed explanation of
 - a. the activity or event supported by the grant monies including the estimated number of participants identified as adults, Junior Daughters, and non-Junior Daughter young women and girls,
 - b. the goal of the activity or event being supported; and
 - c. how the activity or event will bring girls closer to God.
2. A completed Payment Request Form. (Form can be found at www.doknational.org)
3. A completed IRS Form W-9, Request for Taxpayer Identification Number and Certification, is required for payment recipients (individual, church or business receiving the check or wire transfer) receiving grants over \$600. (Form can be found at www.irs.gov)

Guidelines

1. Each application should be for only one event or activity and made by a Daughter in good standing.
2. Alpha Fund grant requests are accepted, reviewed, and paid throughout the year.
3. Requests for grants should be submitted no less than 8 weeks and no more than 6 months prior to the time of expected need.
4. Incomplete applications will not be accepted and considered until all required documentation is received by the Alpha Fund Chair.
