#### THE FAIRFAX LAW FOUNDATION NEEDS YOUR SUPPORT

I know you've heard this before, but it's truer than ever this year: The Fairfax Law Foundation needs your support!

In case you're not aware, the Fairfax Law Foundation is a 501(c)(3) organization and the charitable arm of the Fairfax Bar Association. We are responsible for financially and administratively supporting the Conciliation Program, the Court Tours Program, and the Northern Virginia Pro Bono Law Center. Last fiscal year our programs provided *pro bono* legal assistance to over 700 Fairfax County residents and introduced thousands of local students to our legal system.



We could never do what we do without our amazing attorney volunteers like you, who give freely of their time to conciliate motions, give students tours of the Courthouse and an introduction to our legal system, and provide legal advice and representation to low-income residents of Fairfax County. We appreciate each and every one of our volunteers, and hope that anyone who has not volunteered with one of our programs might consider giving it a try!

However, we also could never do what we do without funding. We are projecting a significant budget deficit this year. While we are very grateful to receive some grant funding, these grants are not sufficient to cover all that we do, and donations are down. We have significant expenses, which largely include compensating the staff of our Northern Virginia Pro Bono Law Center who work tirelessly to screen and connect low-income people in need with volunteer attorneys and to create and facilitate programs that will reach those most in need, as well as covering administrative costs associated with same (such as insurance and software). We pay for the buses and substitute teachers that make our Court Tours Program possible for our local schools. We contribute to the Fairfax Public Law Library to help balance their budget and keep them in operation. We will not be able to continue supporting these efforts, and our programs will falter or perhaps even be eliminated, without increased donations.

There are many ways to donate, including as part of our First Hour Campaign this fall (donating the cost of one hour of your billable time), or as a more committed and ongoing sponsor through our Fellows Program (a commitment to giving a certain amount on an annual basis for a period of years). You can also give whatever amount you want, whenever you want! We are truly grateful for anything, and desperately hope to keep our programs operational with funding from any and all sources.


#### **President's Column**

As someone who never planned any sort of convention, I am forever grateful to our FBA staff, led by Executive Director Courtnie Norris, Assistant Executive Director Jana Sehrer, and CLE/Special Events Coordinator Kerri Yates. Their leadership and experience were indispensable, and I cannot thank them enough for their long hours, hard work, and dedication to this endeavor. I appreciate the numerous reassurances from Courtnie that, "Everything will be fine," and all of Kerri's reply emails that she "handled it." In fact, I apologize to them for the inadvertent stress I undoubtedly caused them with my incessant worrying, especially for things out of my control like the weather. Fortunately, the rain held off throughout the convention with the sun finally peeking out on our last morning there.

With the help of several special FBA members, we planned a robust program with new and innovative CLEs and fun social events. I give my sincerest thanks to the members of our CLE Convention Planning Committee led by the amazing and unflappable Elanna Weinstein, Esq., who is a highly respected family law attorney in Fairfax and President-Elect of the FBA. Under Elanna's leadership, the CLE program came together with the help of Judges Susan Stoney and Tania Saylor and attorneys James Abrenio, Andrew Elders, Roberta Henault, Kim Huguley, Sam Leven, and Theodora Stringham.

Our CLE programming began with our longer day of courses on Friday, which included an informative session about the overlap of criminal law, immigration law, personal injury law, and family law led by attorneys James Abrenio, Patrick Blanch, Bradley Henson, and Elanna Weinstein along with the input of Judges David Oblon, Mark Simmons, and Todd Petit. Later that day, our Public Defender Dawn Butorac and Deputy Public Defender Andrew Elders taught an innovative and new type of CLE—an advanced trial advocacy seminar—in an effort to address the stigma that civil attorneys "do not know" the evidentiary rules. Drawing on their combined experience from hundreds of criminal jury and bench trials, and enlisting the help of Judges Michael Devine and Todd Petit, the presenters treated their audience members to a highly entertaining and enlightening presentation that included a lively discussion of compelling hypotheticals and real-world examples to apply in their daily practice. Finally, Amy Tobias, Esq., along with Judges Robert Smith and Jonathan Frieden, presented an informative, family-law seminar on third-party custody cases.

On Saturday, we concluded the CLE programming with a shorter day of breakout sessions, including a personal injury CLE led by attorneys Sarah Marks and Jamie Alvarado-Taylor and Judges Christie Leary and Susan Stoney; a real estate CLE led by attorneys Sarah Petcher and Janna Wolff; and an employment law CLE led by attorneys Theodora Stringham and Roya Vasseghi .We also had two family law CLEs: Christine Hissong and Sara Schuler led the collaborative law and mediation CLE, while Judge Saylor and attorneys Katharine Maddox and Stephanie Smith led the CLE on toxic advocacy in high conflict litigation, which could have lasted much longer than an hour given the engaging conversation this difficult topic sparked among the seminar's participants.

#### THE CLE COMMITTEE NEEDS YOU!

COVID-19's recent resurgence reminds us of the devastating impact of the virus as we continue to overcome its lingering effects. The Continuing Legal Education (CLE) Committee has faced challenges from the pandemic as well as we have always strived to provide live, in-person programs and face-to-face advice from Fairfax judges and practitioners. We need you to get involved and help us with your ideas and enthusiasm to fully bring us back to pre-pandemic levels of participation.

This past year, we have had some terrific CLEs in person and online that have provided practical assistance to our members. In June, we had a program headlined by Judge Oblon and Elaine Bredehoft teaching the strategies and tactics of civil jury *voir dire*. Elaine provided first hand insights from her representation of Amber Heard in the six week long *Depp v. Heard* trial watched the world over. Judge Oblon gave in-depth instruction and advice based on his oversight of *voir dires* from the bench to guide practitioners through the complex process. Blanca Gonzales, the Fairfax Circuit Court Jury Clerk Supervisor, described the clerk's office's process of calling prospective jurors and preparing the jury *venire*. Kelly Budd moderated, and I had the privilege of explaining the statutes, court rules, and Virginia Supreme Court case law governing jury *voir dire*.

These and other programs are available in our online catalogue of CLE programs at <a href="https://fairfax.inreachce.com/">https://fairfax.inreachce.com/</a>. The available programs cover a range of issues in family law, criminal law, business law, employment law, trial advocacy, real estate law, elder law, and guardianship issues.

In addition, this fall we held numerous programs for every area of practice, including the annual View for the Bench CLE. This year's View from the Bench was taught by Judges Azcarate, Bellows, Mayne, Moliken, Shannon, Sotelo, and VanLowe, as well as numerous practitioners discussing with the judges their advice for litigating in Fairfax courts in a range of practice areas. And we had our Annual Ethics CLE: Navigating Trust Account Integrity CLE regarding the challenging issue of proper trust accounting taught by Elizabeth K. Shoenfeld and Richard Johnson of the Virginia State Bar ethics committee.

I have always found attending FBA's CLE programs as key to my practice of law as the programs allow me and other practitioners in Virginia's most active court system to sit across from the judges and ask them questions about the law. This provides immediate tangible benefits in knowing what to do when appearing in cases before these same judges. These programs also teach specific litigation skills, from selecting and preparing expert witnesses to protecting a judgment on appeal, which members can then apply to their own Fairfax court cases.

Fairfax CLE programs also provide a quick primer in any of these various areas of law. By registering for a two-hour program taught by leaders in the practice area, either in person or online, members can expand their knowledge base and their ability to assist clients.

We at the Fairfax Bar CLE committee are eager to make our programs as beneficial as possible to our members. FBA members can help shape the curriculum we provide and tailor the courses available to their practice goals. Over my years on the committee, I have witnessed first hand how members and judges pick a difficult or changing area of law to develop into a program, identify and coordinate the best presenters, prepare exhaustive written materials, and teach the attendees at the live program.

FBA CLE programs have a history of providing targeted training to members on fascinating and complicated areas of law, and providing these lessons hands-on from Fairfax court judges.

I strongly encourage all FBA members to join the CLE committee, attend FBA CLE programs, and to send the CLE committee ideas for programs they would like to see. At almost every committee meeting we review proposals from members and judges, which become the basis for the new CLE programs we offer. The experience received in facilitating CLE programs has been invaluable to me. They have helped me to learn new areas of law and develop relationships with the best practitioners in these areas. The relationships have greatly strengthened my referral network and made practicing law more enjoyable.

#### Message from the Committee Chair...

It is my great pleasure to welcome you to the Criminal Law Section of the Fairfax Bar Association. This year our Board consists of Negin Farahmand Wood, who is continuing in her role as Chair, Carly Jehlen Hart and Katie Donoghue as Co-Vice Chairs, and Ryan Rambudhan in his role as CLE Outreach Director. The Committee as a whole looks forward over the next year to serve and further the Section's goal to improve the practice of criminal law for our Bar and membership.

The Criminal Law Section seeks each year to hold quarterly CLEs at no cost to its members, These presentations will be in-person and will aim to include both members of the Bench and Bar for discussions on the practice, procedure, and new case law in criminal law. This year, we are pleased to welcome Dr. Travis Flower, a clinical and forensic psychologist, who will present on best ways to prepare this defense. Other CLEs will focus on court appointed representation for attorneys both in civil commitment hearings and criminal practice, including effective representation of juveniles charged with criminal offenses and objections and preservation of legal issues for appeal.

As in the past, this year we also look forward to collaborating with other Bar Sections to co-sponsor continuing legal education programs, promote bench-bar relationships through other events, and provide other opportunities for professional development.

We are an exciting organization with diverse members that come from a myriad of backgrounds within the legal profession, including private attorneys, federal and state defenders, federal and state prosecutors and federal judges. That breadth of membership brings with it a richness of perspectives on the practice of criminal law informed by our respective roles, life experiences, and geography.

#### **CIRCUIT COURT COMMITTEE**

The FBA's Circuit Court Committee is a forum for the Circuit Court and the Bar to exchange ideas, practice tips, and find ways to improve the practice of law in Fairfax. The Committee is open to judges, clerks of court, County Attorneys, Commonwealth's Attorneys, Public Defenders, Legal Services practitioners, members of the FBA Board of Directors, and lawyers who practice in various areas of law. The Committee also consists of Subcommittees, including Domestic Relations, General Civil Litigation, Criminal Law, and the *Circuit Court Manual*. Anyone who wishes to join the Committee can contact the Bar office and be added to the Committee membership.

The Committee and its Subcommittees meet on the third Wednesday of each month at 1:00 PM through Zoom. The Subcommittees routinely plan and hold CLEs on various topics relating to each Subcommittee's respective practice area. Under the leadership of Clyde Christofferson and his Subcommittee, the *Circuit Court Manual* is in the process of being updated for the first time since 2018. Most importantly, the Committee provides an informal setting for practitioners to share ideas, pose practice questions, and learn from one another. From questions relating to e-filing, calendar control, or the interpretation of particular Virginia Code Sections, the Committee provides a forum for these questions to be answered by the Clerk's office, judges, or other practitioners. The Committee also shares information about upcoming *pro bono* and volunteer opportunities and FBA events.

The Committee exemplifies our Bar, which is one that enjoys a strong sense of community and thrives from opportunities to learn from one another. We hope that you will join us. ■

#### 2023 FAIRFAX BAR ASSOSCIATON FALL GOLF TOURNAMENT
