FBA INTERNET VOTING PROCESS FOR VICE PRESIDENT AND BOARD OF DIRECTORS

The Fairfax Bar Association Online Board of Directors election will begin on **Wednesday, June 5, 2019 at Noon** and will end on **Friday, June 7, 2019 at 4:00 PM**. Pursuant to our Bylaws, only Regular and Honorary Members of the FBA are eligible to vote. In order to vote, Regular and Honorary Members must have a valid email address on file with the Fairfax Bar. Each eligible voter will receive an email prior to the opening of the online election with login, username, and password information needed to vote. This email will also contain detailed information on the election process and the candidates. The candidate information also will be placed on the FBA website, www.fairfaxbar.org. Members may vote from any location providing Internet access. A computer will be made available at the FBA office for voting, should any members need to vote at that location.

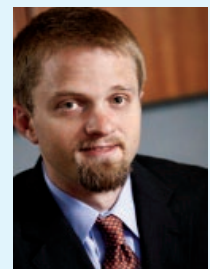

- Speakers for Drivers Ed Program (presented at Chocolate Lovers Festival and area high schools);
- Served on the Prevention Network Subcommittee on Youth for FCPS;
- Access to Law Related Education Programs (Doctor/Lawyer); mock trials for the Community Coalitions (partnership with PTAs);
- Established a program with the 7th grade students of Luther Jackson Middle School on the 50th Anniversary of *Brown v. Board of Education* providing the history and legal analysis of the Supreme Court decision;
- Helped with the establishment of the Color of Justice program and provides volunteers each year;
- Established the Doctor/Lawyer Program (became part of the Devonshire ATOD program in 2001);
- Provided a Spanish Mock Trial for area students (and performed at Chocolate Lovers Festival);

have served on the Circuit Court Committee since 2007. In 2013, I was elected to the FBA Board of Directors. I have acted as General Counsel to the Board, Secretary, and I am the current Treasurer.

What do you see as the FBA's priorities?

The goal of the FBA should be to facilitate excellence within the legal profession. The achievement of this goal directs the FBA's priorities: (1) to advocate for resources for Fairfax County Courts, including the full staffing of the judiciary, and to provide input on selection of judges; (2) to educate our members about recent developments in the law across a wide spectrum of practice areas; (3) to foster opportunities for networking and collegial relationships among members of the Bar; and (4) to support programs and efforts that provide legal services for those who face financial or other obstacles to the legal system.

Aaron J. Christoff, Esq., Law Office of Aaron Christoff, PLLC (Incumbent)

Please state your FBA involvement, including committee work, programs, and project participation and initiative.

I've been on the FBA Board of Directors since 2016 and currently serve as its General Counsel. I've been a member of the Circuit Court Committee since 2009, and its Domestic Relations Sub-Committee since 2009. I've been on the Legislative Committee since 2009 and served as its Vice-Chair and Chair during that time. From 2009–2010 I was also a member of the Juvenile and Domestic Relations Committee. Since 2014 I've been a member of the FBA's Judicial Funding Task Force.

What do you see as the FBA's priorities?

I think specific priorities of the FBA include continued efforts to make sure the Fairfax court system is accessible and usable by the public, whether or not they can afford legal counsel. The *pro bono* courses and publications are a big part of this.

What resources and talents will you share if elected to the FBA Board, and how?

The best resources I have to offer the FBA Board are my time and commitment to dedicating that time to doing whatever I can to improve the FBA. Over the last few years, I've spent considerable time on the Board of Directors, committees, task forces, and volunteer programs. I believe those that have worked with me on these various FBA activities would confirm that I am not satisfied simply being a participant or saying that I am a member of something. When I join something, I am an active participant who volunteers to take on added responsibility and tasks to get done what needs to be.

Matthew C. Perushek, Esq., Sickels, Frei & Mims, L.L.P. (Incumbent)

Please state your FBA involvement, including committee work, programs, and project participation and initiative.

Most of my involvement in the FBA has been through the Young Lawyers Section. I have been on the YLS's Board of Directors since 2012, beginning as the Law Clerk Liaison and culminating with my term as President from 2017 to 2018. During that time, I helped organize and run nearly every event the YLS hosts, including the New Attorney Orientation CLE; the spring CLE, the topic of which changes yearly; the breakfast and cocktail events with our judges, which occur a total of four times per year; Lawyerpalooza, the annual barbeque at Hunter House in Vienna; and monthly happy hours. As President, I led the Board as it organized these events and others for our members. I continue to serve on the YLS's Board as Past-President, and I sit on the FBA's Board of Directors in that position.

Outside of the YLS, I have served on the organizing committee for the annual 5K. I have attended and volunteered at the 5K several times. I have attended the FBA Convention, and I have attended the Bench Bar Dinner Dance many times.

What do you see as the FBA's priorities?

The FBA's mission is to serve its members, and that should be the top priority that guides its Board of Directors. We can best serve our members by continuing to improve the practice of law in our area.

The quality of our local bench unquestionably affects what it is like to practice law here. An important function of the FBA is to screen potential judicial nominees through the Judicial Screening Committee. The Supreme Court of Virginia's recent caseload study confirmed what we all know to be true: our courts have heavy dockets. It is important that judicial vacancies are quickly filled, and the first step in the process is ensuring that the most competent and qualified candidates are considered by our legislators. The FBA's judicial screening does just that.

The FBA must continue the work of its Committees, which also improves the practice of law here. The Circuit Court Committee, General District Court Committee, and Juvenile & Domestic Relations Court Committee work closely with their respective courts to make recommendations to the judges and the clerks. Those recommendations frequently result in changes to standard court policies and procedures that benefit us and our clients. The bench frequently does not realize the problems we deal with as attorneys, and the Committees are able to bridge that gap.

Our members benefit when the public has trust in the legal system and our courts, and that trust is unquestionably enriched by positive interactions with our attorney members. The FBA helps ensure resources are available to the public, including the Lawyer Referral Service, court tours, and the Law Library, which is open to the public. The YLS recently hosted the Color of Justice program, which exposed over one hundred local students to the legal system. A number of judges and attorneys volunteered their time on a Saturday to speak with these students about what it is like to be an attorney. Multiple parents raved about the event, and it certainly helped our image in the community.

Finally, the FBA must continue to host events that benefit our members. The practice of law is more enjoyable when you know your colleagues, and the FBA offers a number of opportunities to meet and interact with other attorneys. The Sections offer networking events for attorneys with similar practice areas. Many Sections also provide CLEs for members at very reasonable prices. And the FBA provides a mix of CLEs and networking with its Annual Convention as well.

THE AMERICAN BAR ASSOCIATION MID-YEAR MEETING REPORT

I had the pleasure of attending my first ABA meeting as a member of the House of Delegates. This was the 80th Mid-Year Meeting of the American Bar Association (ABA), which was held January 23-28, 2019, at the Caesars Palace Hotel, Las Vegas, NV. A variety of programs were sponsored by committees, sections, divisions, and affiliate organizations. The House of Delegates is the policy-making body of the ABA and meets twice a year. The real governing body of the ABA is the Board of Governors who meet and carry out the actions of the ABA when the House of Delegates is not in session, not inconsistently with any action taken by the House. The Board of Governors consists of 44 members, including 19 district representatives, 18 members-at-large, and 6 officers who serve *ex officio*. There are over 589 members of the House of Delegates. More than two-thirds of the Delegates serve in private practice, thirteen percent are government attorneys and/or members of the judiciary, and six percent are corporate attorneys. Of the sixty-nine percent who serve in private practice, thirty-seven percent are solo or small firm practitioners, twenty-seven percent are medium firm practitioners, and thirty-six percent are in large firms. The average age of a Delegate is roughly sixty (I'm happy to say I haven't gotten there yet). Women make up forty-one percent of the House membership. Nearly one in five Delegates identified themselves as ethnically diverse. There are four hundred thousand members of the ABA, a budget exceeding two hundred million dollars, and three hundred million dollars in investments.

The House of Delegates meeting was an all-day, non-stop event. There was a broad range of issues that were presented to the delegation. There were many proposals debated. Some passed; some did not.

The report by the Treasurer unveiled the new membership model that will begin fiscal year 2020. There will be repricing at that time, which will impact the dues revenue, because our dues will be going down. Currently, there are one hundred fifty-seven price points for dues, but under the new model there will only be five. One of the many additional membership benefits will be membership in the Law Practice Division and Solo, Small Firm General Practice Division, which will be available to every member of the ABA at no additional cost so long as a member opts into those Divisions. Additionally, the Center for Professional Responsibility information will be generally available at no cost to members. The ABA will be coming out with a new logo May 1, 2019, and the tagline will remain the same: "Defending Liberty, Pursuing Justice."

Some of the most notable items that were discussed by the House of Delegates were the following:

- **Civil Rights and Social Justice:**

The Section of Civil Rights and Social Justice proposed urging the federal judiciary, Congress, and Department of Homeland Security to enact legislation and adopt policies to protect the privacy interests of those crossing the border by imposing standards for searches and seizures of electronic devices, protection of attorney/client privilege, the work product doctrine, and lawyer-client confidentiality. This Resolution was approved.

- **Criminal Justice:**

The Section of Criminal Justice proposed urging the Attorney General to rescind the "Zero Tolerance" and "Operation Streamline" policies that mandate the prosecution of all persons alleged to have improperly entered the United States for the first time, a misdemeanor under U.S.C. §2325; end the practice of expedited mass prosecution of immigrants, and allow for an individualized determination in deciding whether to file criminal charges. This Resolution was approved.

- **Criminal Justice:**

The Section of Criminal Justice moved Resolution 109B urging federal, state, local, territorial, and tribal legislatures to define criminal arrests, charges, and dispositions that are eligible for expungement or removal from public view by sealing, and set out procedures for individuals to apply for the same. This Resolution was approved.

What resources and talents will you share if elected to the FBA Board, and how?

I am currently a member of the General District Court, J&DR, and Circuit Court Committees.

What do you see as the FBA's priorities?

The FBA should prioritize clear communication between practitioners, judges, court staff, and other officials. Of all the jurisdictions that I practice in, the Fairfax FBA has created a model to streamline information across all channels which we very much appreciate. Additionally, the FBA focuses on providing CLEs that not only provide an opportunity to learn the law, but an opportunity to understand the unique situations that arise while practicing in Fairfax. I also believe that an important priority for the FBA is fundraising. It's clear that we continue to communicate that fundraising is not merely a method of raising money, but a way to collectively promote our message, goals, and initiatives.

What resources and talents will you share if elected to the FBA Board, and how?

- **Disaster Relief:**

The Virgin Islands Bar Association moved Resolution 10C opposing the withholding by the Executive Branch of funds previously appropriated by Congress for disaster relief and recovery, or their diversion for other purposes. This Resolution was approved.

- **Domestic and Sexual Violence:**

The Commission on Domestic and Sexual Violence moved revised Resolution 115 opposing the imposition upon sexual assault victims of a legal burden of resistance before legal protection attaches, and urges federal, state, local, territorial, and tribal jurisdictions to oppose laws or rules that allow consent to sexual activity to be inferred in whole or in part from inaction or lack of verbal or physical resistance. This Resolution was approved.

I was surprised that the two following resolutions were necessary:

- **Criminal Justice:**

The Section of Criminal Justice moved Resolution 109C urging federal, state, local, territorial, and tribal legislatures to enact legislation to provide correctional and detention facilities with unrestricted access to free toilet paper and a range of free feminine hygiene products, in sufficient quantities to address their needs. This Resolution was approved.

- **General Practice:**

The Young Lawyers Division moved Resolution 101A encouraging federal, state, local, territorial, and tribal legislatures, and court systems, in conjunction with state and local bar associations, to support and assist with the establishment and maintenance of lactation areas in courthouses for members of the public, including lawyers, jurors, litigants, witnesses, and observers.

Two hotly debated topics involved law school accreditation and neutral pet policies for families living in military housing:

- The Section of Legal Education and Admissions to the Bar put forth, for the second time, Resolution 105 in making amendments dated January 2019 to Standard 316 (Bar Passage) of the ABA Standards of Rules and Rules of Procedure for Approval of Law Schools. Standard 316 requires all law schools to achieve a 75% bar pass rate for all graduates within two years of graduation. The criticism has centered on what the change would mean for diversity and inclusion in the profession. It was highly debated. The House voted not to approve, with 88 voting for and 334 voting against. Unfortunately, due to the fact that this was the second time the Resolution was before the Delegation, it could be acted upon, despite the overwhelming vote in opposition. The Council of the Section of Legal Education and Admissions to the Bar has the final decision related to law school accreditation.

- The Tort Trial and Insurance Practice Section proposed Resolution 112, dealing with animal rights. It's hard to believe that this body of governance could spend as much time as it did debating whether or not we should encourage Congress and the United States Department of Defense to direct the Armed Forces and its Public Private Venture housing contractors to enact uniform breed-neutral pet policies for families living in military housing. The measure was ultimately approved.

The annual meeting of the American Bar Association will be held in San Francisco from August 8-13, 2019. ■

The Color of Justice

The Color of Justice rotates among local bar association hosts each year, including the Northern Virginia Black Attorneys Association, the Northern Virginia Woman Attorneys Association, the Hispanic Bar Association of Virginia, and the Asian Pacific American Bar Association of Virginia.

This year, hosted by The Hon. John M. Tran, more than sixty (60) volunteer judges and attorneys presented a mock criminal case to more than a hundred (100) student participants and assisted the children with “deliberating” in small jury groups. After the hour-long informative, humorous trial performed by local attorneys in courtroom 5J of the Fairfax County court house, replete with exhibits projected using the courtroom technology, the students were permitted to use court rooms and jury rooms for deliberations. The students, their parents, teachers, and Fairfax County Public Schools college preparation personnel were treated to a lively pizza lunch, where the students were permitted to continue engaging with their assigned judicial and attorney volunteers to facilitate further discussion and understanding of the evidence and to obtain valuable career advice.

Following lunch, the students and volunteers re-assembled in courtroom 5J for a full group discussion of the student jury verdicts, announced by a foreperson of each jury, speeches from the judicial panel, the announcement of voluntary essay contest winners, and the issuance of scholarship awards. Attorneys and students alike enjoyed the exclusive opportunity to learn about the challenges and rewards that the judicial panel members shared from their experiences in their personal lives and legal careers. While all student participants were recognized with commemorative t-shirts, pens, and notebooks for deliberations, the FBA congratulates the following students who received top prizes in the essay contest: Anjali Maddipatla, Isaiah N. Mamo, and Alex Hall.
