Members may vote from any location providing Internet access. A computer will be made available at the FBA office for voting, should any members need to vote at that location.

President's Column

It's hard to believe that I am reaching the end of my tenure as President of the Fairfax Bar Association. As the first African American president and the first African American woman to serve in that role, I wanted to trailblaze. I wanted to make a difference, take a stand, and unite voices. Unfortunately, this year changed a lot of things for everyone; how we did business



year changed a lot of things for everyone; how we did business, how we saw ourselves in the world, how we lived, and how we saw the world.

Although we were faced with immeasurable challenges, we managed to be inventive. We found different ways to do our craft and serve our clients while making a living. It wasn't easy, and there were numerous bumps on the way, but my exposure to all the amazing committees that represent the Fairfax Bar Association really showed me that the commitment is there—it always has been, and it always will be.

In writing my first article, I began with a quote from Harriet Tubman, "Every dream begins with a dreamer." I had big dreams for our bar association because we were embarking on new faces coming together, cultivating the long unrecognized talents that our membership had to offer, which needed to be acknowledged and utilized. At the time that I came into the presidency, the world was changing. We were confronted with some ugly truths: what roles that we play in the world and what differences we could make. We began to acknowledge the implicit bias that we see and experience every day in our legal field but have glossed over as "normal." We talked about the need for diversity in the legal field, made incremental movements, but still didn't address it head on. It's hard to think that you are the exception and not the rule. This year forced us to take a hard look at our environment and acknowledge that it didn't look right.

One of my mentors, Judge Gerald Bruce Lee, has frequently ended his guidance with the phrase, "To whom much is given, much is required." This being the concept that when you are blessed with opportunity, then you have the responsibility to give back, and make a real difference. I wish I had more time. I learned so much in my role as president and saw the impact an organization such as the FBA can have on our community even beyond the legal community. This year everyone experienced an era of awareness. Life-altering experiences occurred this year, beginning with the murder of George Floyd, and then the killing of others that culminated in legal review that placed the entire country on trial.

Despite the reckoning of justice, there is so much work to be done and we are just beginning to come to terms with our roles in society. Social injustice, systemic racism, the real conclusions that there is disparate treatment of individuals and that the world is not color-blind, were the topics of the year. This past year, we couldn't do the "fun" things that brought us together as a legal community, such as the FBA Annual Luncheon where I could tell you funny stories, get my president's hat (an ongoing tradition), or really get to tell you who I was, what I had planned to do, and what I envisioned for our bar, our members, and the community in which we serve. We didn't get an opportunity to travel together to Charleston, where we could kick back and be together, but we did grow. We tried something new...at least new for us at the time. The virtual convention. With the virtual convention, we touched on sensitive issues that I am very proud were presented and that need to be a mainstay in our vernacular, such as implicit bias toward individuals who appear in our court, as well as disparity of treatment of attorneys of color as they represent their clients.

We made some sweeping changes and started the discussion for greater awareness and more improvement. For that, I am excited and extremely proud.

Emily C. Baker (Incumbent) - Feldesman Tucker Leifer Fidell LLP

Please state your FBA involvement, including committee work, programs, and project participation and initiatives.

I have been actively involved in the Fairfax Bar for over seven (7) years. I have been on the Young Lawyers Section board since 2014. I first served on the Young Lawyers Section board as the law clerk liaison, then as secretary, and finally was elected President for the 2019-2020 board year. The Young Lawyers Section hosts numerous events each year for its members. As President I worked with our board to organize these events and to ensure that they ran smoothly. As President-Elect of the Young Lawyers Section, I was also involved with Color of Justice as the Young Lawyers Section was responsible for organizing it that particular year. In addition to my work with the Young Lawyers Section, I have been on the Run for Justice 5k Committee for two years and have volunteered at the run for the past few years.

of Justice program, they work closely with the Committees, and they attend social functions like the Bench Bar Dinner Dance and the Annual Golf Tournaments. Membership in the FBA gives you direct access to the bench through these and a variety of other opportunities. It also gives you the opportunity to develop your relationship with fellow attorneys. Finally, the FBA gives you access to low-cost CLEs on a variety of different subject matters.

What resources and talents will you share if elected to the FBA Board, and how?

I am organized and detail-oriented, which are important qualities when running an organization as large as the FBA. Perhaps more importantly, when I decide to get involved, I throw myself all in. Please state your FBA involvement, including committee work, programs, and project participation and initiatives.

I am a member of the General District Court, J&DR District Court, and Circuit Court Committees. As a member of the GDC Committee, I served as co-editor of the GDC Pre-Trial and Alternative Sentencing Programs manual. This manual provides practitioners with invaluable resources that their clients can utilize to seek rehabilitative treatment and avoid incarceration. Currently, I am a member of the Judicial Screening Committee and have participated in multiple interviews for prospective judicial candidates. Additionally, I serve as an Ombudsman for the FBA General District Court Judicial Feedback Program.

If elected to the FBA Board, how would you respond to the question, "Why should I join the FBA?"

The FBA is an invaluable resource for both experienced and newly admitted members of the bar. When I was a new lawyer, I often felt intimidated stepping foot into Fairfax Courthouse: there are many large courtrooms occupied by seasoned practitioners, judges, and courthouse staff. After joining the FBA, much of my angst was alleviated; I was able to learn best practices by engaging with these very same lawyers, judges, and clerks at networking events hosted at local establishments (i.e., bars and restaurants!). Additionally, the FBA provides highly relevant CLEs at discounted rates. Almost always, these CLEs are presented by local practitioners, and current or retired Fairfax judges. In my experience, these CLEs are superior to those offered by any other bar association because they are narrowly tailored to those who practice in Northern Virginia. The FBA provides a sense of community that is comforting, especially during this trying time. There are virtual happy hours and social events to promote community, which is always helpful. Most importantly, we have a lot of fun together! You will have the opportunity to participate in fundraisers such as 5Ks, golf tournaments, and even an annual "Bench Bar Dinner Dance!"

What resources and talents will you share if elected to the FBA Board, and how?

Because I focus on traffic and criminal representation, I am in court almost every day. This provides me with the opportunity to observe dockets and engage with members of the Bar. I am aware of the unique issues that both judges and practitioners experience and am always eager to identify solutions and serve as a mediator. Additionally, my practice area allows me to appear regularly before the GDC, J&DR, and Circuit Courts. I currently serve as Vice President of the Main Street Green Homeowners Association and have served on the board since 2014. I was vice-chair of the Legislative Committee from 2014 through 2016 and was chair of that committee from 2016 through 2018. I was on the Board of the Young Lawyers Section from 2010 through 2014. I have also been a judicial funding liaison for the Circuit Court.

Committee members provide valuable insights and recommendations to the Bench each month and also volunteer their time to serve on subcommittees tasked with updating the *J&DR Circuit Court Manual*, soliciting nominees for the Kassabian Award, and brainstorming ways to address the various challenges observed by both judges and practitioners.

Over the last year, our efforts as co-chairs of the JDRDC Committee have been largely devoted to helping the Bench inform and educate practitioners about new procedures implemented during the midst of the unprecedented COVID-19 pandemic.

THE FAIRFAX PUBLIC LAW LIBRARY IN 2021

Supporting FBA and Court Functions in these Challenging Times

The Fairfax Public Law Library has been open during the Pandemic, with social distancing and glass barriers to protect our librarians and the public. We are the only full-service law library that has remained fully operational and open in the greater Northern Virginia area. Working closely with the FBA, the Law Library has been providing support services to members of the Bar that are provided by the FBA when the Bar Association office is open, including modest fee-based copies, fax, and print services. As the Courthouse transitions toward normalcy, with the return of civil and criminal jury trials and other court functions that were curtailed during the Pandemic, the Law Library will continue to provide important services to the Courts, the Clerks' Offices, and other Courthouse personnel.

We are, and for many years have been, a source for information and research into the workings of the Circuit Court, the General District, and the Juvenile and Domestic Relations District Courts. The Clerks and the Judges refer lawyers and *pro se* litigants to the Law Library on a daily basis. We are in many ways the safety net for *pro se* litigants who do not qualify for LSNV or Public Defender representation. The service we provide to the public is one reason the Law Library was located on the first floor next to the Public Service counter in the last Courthouse expansion.

Our superb library staff, Thomas Pulver, Library Director; and Cathryn (Cat) Butler, and Teresa (Terry) Warkel, Law Librarians, work to remain current on the court procedures in all three Courts in the Courthouse as well as appellate courts, directing Bar members and pro se parties to relevant forms and processes. Our Library Director holds a Masters Degree in Law Library Science from the premier law librarian program in the country, Catholic University of America. Before Tom's distinguished tenure with the Law Library, he was a professional law librarian, having worked previously for Am Law 100 firms. Cat Butler and Terry Warkel are both attorneys and bring a wealth of knowledge to their positions, supporting the research needs of our constituency. We are most fortunate to be served by this team. Our services include:

Research Tools - The Law library maintains online research coverage with Lexis, Westlaw, CaseFinder, and HeinOnline. Our research tools include comprehensive national and Virginia-specific coverage, including Virginia, other state, and federal cases nationally on all reported trial and appellate levels, frequently cited law treatises, journals, and law reviews. Cases and other materials often can be emailed in popular formats (PDF, Microsoft Word, and even WordPerfect) at no charge.

We maintain comprehensive Virginia legal resources, including hornbook sets, form books, and Virginia CLE materials, in both paper and electronic form. Our stacks include Maryland, DC, and West Virginia codes, and many single and multi-volume sets and regional reporters, many of which are updated through our electronic research tools. One important resource we maintain that is important to Virginia lawyers is our archive of past *Code of Virginia* volumes, a valuable tool for those tracing predecessor *Code* sections to current laws. Researchers can only trace this history in a comprehensive, learned fashion through the printed superseded *Codes*. While statutory history in current *Code* volumes is helpful, much of it is in summary form or truncated.

Our online resources also provide a valuable service to Bar Association members in small firms that wish to avoid costly online subscription costs.

Video Teleconferencing - The Law Library maintains video teleconferencing equipment in our conference room, a service that is free to FBA members. This service is very useful during the Pandemic, and beyond, for remote depositions, electronic notarization, and other services.

Computer Lab - We have twelve workstations, including a teacher/seminar leader's station, with an 80-inch, high-definition flat screen monitor in our computer lab. Users can connect to the monitor through the desktop computers or through a personal laptop. These resources are not only available to FBA members, but are also an important service to the Clerks of the Courts and other government employees working in and around the Courthouse. For Fairfax County Government employees, these services supplement the resources at the Government Center and enable personnel to avoid trips to the Government Center, reducing car trips.

Conference Room - The Law Library conference room can be reserved for meetings, conferences, client intake and background interviews, Commissioner's hearings, and marriages solemnized in the Courthouse.

The Fairfax Public Law Library is privileged to maintain our long tradition of service to FBA members and other attorneys, *pro ses*, Judges, Court Clerks, the Commonwealth Attorney's office, LSNV, Public Defender, Fairfax County Police and Sheriff's Departments, other Fairfax County government personnel, and other users, as the largest local courthouse based law library in Virginia. The closure of the George Mason University Law Library to the public has increased the needs of Northern Virginia for access to a comprehensive public law library. We are here to serve you. ■

WHO ARE PARALEGALS?

The paralegal profession is relatively new. It began in the late 1960s/early 1970s when it became apparent law firms and practitioners needed to provide more efficient and cost-effective legal services to consumers. Paralegals are not required to have any formal education. They are qualified by education, work experience, and training. The terms "Legal Assistant" and "Paralegal" are often used interchangeably.

The National Federation of Paralegal Associations (NFPA) is the first national paralegal organization, founded in 1974. The Association, comprised of more than 50 member associations, monitors legislation, ethics, and case law that affects the paralegal profession. NFPA defines a paralegal as:

A paralegal is a person, qualified through education, training or work experience to perform substantive legal work that requires knowledge of legal concepts and is customarily, but not exclusively, performed by a lawyer. This person may be retained or employed by a lawyer, law office, governmental agency or other entity or may be authorized by administrative, statutory or court authority to perform this work. Substantive shall mean work requiring recognition, evaluation, organization, analysis, and communication of relevant facts and legal concepts.

The National Association of Legal Assistants (NALA, established in 1975) states:

Paralegals are qualified by education, training, or work experience and are employed or retained by a lawyer, law office, corporation, governmental agency or other entity to perform specifically delegated substantive legal work for which a lawyer is responsible.

In 2020, the American Bar Association (ABA) adopted the following definition:

A paralegal is a person, qualified by education, training, or work experience who is employed or retained by a lawyer, law office, corporation, governmental agency or other entity and who performs specifically delegated substantive legal work for which a lawyer is responsible.

The Virginia Alliance of Paralegal Associations (VAPA, established in 1989) provides the following definition of a paralegal:

. . . [A] paralegal is a specially trained individual who performs substantive legal work that requires knowledge of legal concepts. Paralegals either work under the supervision of an attorney, who assumes professional responsibility for the final work product, or work in areas where law individuals are explicitly authorized by statute or regulation to assume certain law-related responsibilities.

As is evident from the definitions utilized by these notable legal organizations, education, training or work experience are key to a paralegal's qualifications. The common thread of the definitions is that a paralegal performs substantive legal work under the supervision of an attorney.

Despite the definitions above, paralegals remain unregulated and unlicensed. Credentials are offered only on a voluntary basis. Many paralegals choose not to obtain any credentials, relying instead on their work experience.

For those paralegals who choose to obtain credentials, there are two distinctions:

A paralegal is "certificated" if they have completed an ABA-approved paralegal program and received a certificate of completion. Such programs are offered at many higher learning institutions throughout the country.

A paralegal is "certified" if they have successfully taken one of the many exams available for paralegals. Some of those exams are:

- NFPA offers two credentialing exams, Paralegal CORE Competency Exam™ (PCCE™) and Paralegal Advanced Competency Exam® (PACE®):
 - The <u>Paralegal CORE Competency Exam™</u> (PCCE™) establishes that education has prepared a paralegal for many types of paralegal work and helps him/her stand out from others whose schooling and experience are otherwise similar. Those who have passed the PCCE may proudly display the CRP™ designation after their name. This exam, offered through NFPA, is for entry level paralegals.

• The Paralegal Advanced Competency Exam® (PACE®) is for those with not only a comprehensive education in paralegal studies but also years of practical experience. Earning the RP® designation by passing the PACE shows that a paralegal is one of the best in the field. NFPA offers this exam for paralegals who have substantial experience.

2. NALA also offers two exams:

- The Certified Paralegal Exam (CP), a five-part test in areas of communications, ethics, legal research, substantive law and judgment/analytical thinking. "Use of the CP credential signifies that a paralegal is capable of providing superior services to firms and corporation."
- Advanced Paralegal Certification (APC) is also available through NALA for those who have successfully passed
 the CP Exam. APC is focused on mastery of specific course material developed under the direction of the
 Advanced Paralegal Certification Board. As assessment component is part of the curriculum-based program as
 well as detailed exercises. Presently, NALA offers APC credentials in 26 practice areas. The APC is designed to
 recognize that once a Certified Paralegal's career is launched, there is a need for advanced CLE programs.
- 3. NALS, the Association for Legal Professionals, offers four credentialling opportunities. From their website, www.NALS.org:
 - Accredited Legal Professional (ALP). The ALP® is designed for students and entry-level professionals looking to get their foot in the door of the legal profession. It is often used as an exit exam for legal studies programs and serves as a great way to complement what has been learned in the classroom. Attaining this goal demonstrates commitment and aptitude for succeeding in the ever-changing legal environment and provides an opportunity to begin your career a rung above the competition.
 - Professional Legal Secretary (PLS) and/or Certified Legal Professional (CLP). The PLS® and/or CLP® is designed for individuals with a minimum of 3 years of legal work experience who are looking to establish their credentials nationwide as a Professional Legal Secretary or Certified Legal Professional. Attaining this goal demonstrates a mastery of office skills, the discipline to assume responsibility and exercise initiative and judgment, dedication to professionalism, and acceptance of the challenge to be exceptional.
 - **Professional Paralegal** (PP). The PP® is designed for students graduating from an ABA-approved legal studies or paralegal studies program OR individuals with a minimum of 5 years of paralegal/legal assistant experience who are looking to establish their credentials nationwide as a Professional Paralegal.

Some states have begun licensure and regulation of paralegals or have specialty certifications in various areas of law:

- In 2000, California began licensing LDAs "Legal Document Assistants" who are allowed to act without supervision of an attorney after undergoing training and after having been certified and bonded by the state. The LDAs may:
 - * Distribute to their clients legal materials that have been published or approved by a lawyer;
 - * Prepare clients' legal documents under the direction of the clients;
 - * File clients' legal documents in the appropriate courts.
- In 2012, the State of Washington adopted APR (Admission and Practice Rule) 28 to address the gap between those individuals in need of legal services and those able to afford those services. APR 28 established a program for Paralegals to become Licensed Limited Legal Technicians ("LLLT"). LLLTs were designed to assist only in the area of family law and help those in need of a divorce, legal separation, child support modification, parenting plan modifications, domestic violence protection orders, establishing a parenting plan and child support for unmarried couples, establishing paternity, and notices of relocation.

After just 8 years following the start of the program, and 5 years after the licensure of the first LLLT, Washington is phasing out the program due to the cost of sustaining the program and lack of interest by participants. There are less than 40 active LLLTs and only those enrolled by June 4, 2020, who will be able to complete the program requirements as of July 31, 2021, will be eligible to be licensed. LLLTs in good standing may continue to provide services.

It is unfortunate that the program is being terminated, as the need for affordable legal services has not decreased. Paralegals throughout the country were eagerly watching Washington's program with hopes of similar programs in other states.

• In 2018, the Utah Supreme Court passed a rule allowing Licensed Paralegal Practitioners (LPPs) to practice in areas of family law, debt collection, and landlord-tenant disputes without direct supervision of an attorney. An LPP is considered a step up from a paralegal and a step down from a lawyer. Licensure is required.

Of course, no paralegal, whether certificated, certified, or licensed, may ever provide legal advice to a client, which would be the unauthorized practice of law.

Your career as a paralegal can be as varied as you like! Find what area of law you are passionate about and specialize in that. Paralegals have careers in Bankruptcy Law, Corporate Law, Estate Planning and Probate, Family Law, Immigration Law, Labor Law, and Litigation. Paralegals also work as Legal Transcriptionists, Nurse Paralegals, and Real Estate Paralegals. Paralegals find employment not only with law firms and solo practitioners but also with title companies and real estate firms, corporations, public defenders, non-government organizations, state and national judiciaries, government organizations, insurance companies, medical companies, and hospitals.

Want to be your own boss? Become a freelance or contract paralegal! Freelance paralegals do not work for a company or law firm, but instead hire themselves out to companies on an as-needed basis under a contract, not on a payroll. There are benefits and drawbacks to being an independent paralegal. You are your own boss, can set your own hours, and choose your working relationships and projects. But owning a business can be time-consuming and challenging and if you are not disciplined and motivated, you set yourself up for failure.

Where is the paralegal profession headed? Most analysts seem to agree that the field will continue to grow. An area of concern held by many paralegals is that due to lack of formal regulation, anyone can call themselves a paralegal. Certification assists in identifying who maintains their legal education and knowledge, but the certification and education are voluntary. Most certified paralegals favor regulation and required annual CLEs. Their certification sets them apart from uncertified paralegals. This does not necessarily mean they are any more skilled than an uncertified paralegal, just that they have taken action to formally prove their knowledge and experience.

The costs of legal services are high, and affordable legal services are needed throughout the country. Paralegals are able to provide those legal services, wherever they are employed. ■

FBA LEGISLATIVE COMMITTEE REPORT

The Legislative Committee meets to discuss, monitor, and promote legislation that may be of interest to FBA members. Most of these issues arise in the Virginia General Assembly. A key function of the Legislative Committee is to monitor and report to the Board of Directors on potentially relevant legislation. The Board then determines whether the FBA should advocate for or against a particular bill. If the FBA wants to advocate for or against a particular piece of legislation, the Committee members may contact other FBA members, delegates, and senators to express our organization's view. As attorneys, we are often able to present unique arguments to elected officials on the possible consequences of a bill.

The FBA focuses on legislation that has the potential to impact the administration of justice, and avoids more partisan issues such as taxes, transportation, or health care. As has been true of many things this year, due to the pandemic, both the General Assembly session and this year's Legislative Committee were a bit more constrained than usual. Legislators were each limited to seven bills, resulting in a significantly shorter list of bills to review than in most years. Still, the session saw several proposed bills of interest, if none where the FBA took a position for or against. Interesting examples from this year's session (several likely to be recurring issues addressed by the General Assembly in the coming years) were:

- HB 1759 and SB 1242 These bills allow defendants to appear by two-way electronic video rather than in person under certain circumstances, reflecting the issues raised this year with trying to limit the spread of Covid while still allowing access to justice.
- HB 2113 Establishes a process for the automatic sealing of police and court records, defined
 in the bill, for certain convictions, deferred dispositions, and acquittals, and for offenses that
 have been nolle prossed or otherwise dismissed. The bill also allows a person to petition for
 the sealing of police and court records relating to certain convictions. The bill has staggered
 delayed effective dates in order to develop systems for implementing the provisions of the bill.
- SB 1108 Increases from \$25,000 to \$50,000 the maximum civil jurisdictional limit of general district courts.
- SB 1180 Provides that a circuit court may enter an order joining, coordinating, consolidating, or transferring civil actions upon finding that separate civil actions brought by a plaintiff on behalf of multiple similarly situated persons involve common questions of law or fact and arise out of the same transaction, occurrence, or series of transactions or occurrences.

As the FBA membership is likely aware, one of the most consequential bills passed by the General Assembly this year was SB 1261, which expands the jurisdiction of the Court of Appeals to provide an appeal of right in every civil case, and further increases the number of judges from eleven to seventeen. This will have a significant effect on civil litigants' ability to get review of unfavorable rulings. It's time for civil litigators to brush up on the Court of Appeals procedure!

LAWYER REFERRAL UPDATE

From its humble beginnings in the early 1980's when a Rolodex file of attorneys was used to assist with citizen queries, the FBA Lawyer Referral Service (FBA LRS) has grown to provide thousands of citizens each year with assistance in obtaining legal help. In any given year, 2,000 to 2,500 referrals are processed by FBA LRS employees, and four times that number of phone calls and Internet requests are fielded from those requesting general information and referrals to consumer, governmental, and other agencies.

The FBA LRS has continued to improve its operations and has morphed into one of the country's premier referral services. We continue to be certified by the American Bar Association as meeting its standards for a referral service; something achieved by only a fraction of the referral services nationwide.

Additionally, our panel members have benefited from recent sources of advertising through our marketing endeavors.

In the past couple of years, we have chosen to focus on Internet-based referrals and have implemented a successful Google AdWords campaign. The courts as well as other consumer and governmental organizations also continue to provide strong sources of referrals.

As with most businesses, normal operations ceased in March 2020.

The week of March 16, 2020, began with the installation of new computers in the newly occupied LRS offices located in the Burkholder Building. It was anticipated that the office would have to close down for one or two days if all went well with the installation. And then our plans changed dramatically when we received word that the Fairfax Bar office would close beginning that next Monday due to the pandemic.

How to work remotely when your entire work process depended on office-based hardware using non-Cloud-based software? Calls for referrals came in on county phone lines located in our offices and we were assured by county IT personnel that the calls could not be forwarded to our homes. Before Covid 19, we had not had to remotely access either phone or email referral requests, or process credit card payments outside the confines of our office.

Fortunately, we were able to solve these issues and managed to stay open during the initial three-week Bar shutdown as well as the indefinite Bar shutdown that came later. Though we have experienced a contraction in our operations due to the pandemic, the referral service has helped thousands of citizens access and obtain legal assistance over the past thirteen months. FBA LRS referrals resulted in annual income to member attorneys in FY20 of approximately \$1.2 million and we expect FY21 to result in approximately \$1 million of such annual income.

As the FBA LRS continues to strive to provide this vital public service, we appreciate the support of our members as well as those attorneys not a part of our service who use the LRS as a resource to refer clients they are unable to assist. If you are contacted by a potential client and find that the matter is outside your particular area of practice, we certainly would appreciate you sending that potential client to the FBA LRS. 
