#### FBA LEGISLATIVE COMMITTEE REPORT 2022

The Legislative Committee meets to discuss, monitor, and promote legislation that may be of interest to FBA members. Most of these issues arise in the Virginia General Assembly. A key function of the Legislative Committee is to monitor and report to the Board of Directors on potentially relevant legislation. The Board then determines whether the FBA should advocate for or against a particular bill. If the FBA wants to advocate for or against a particular piece of legislation, the Committee members may contact other FBA members, delegates, and senators to express our organization's view. As attorneys, we are often able to present unique arguments to elected officials on the possible consequences of a bill.

The FBA focuses on legislation that has the potential to impact the administration of justice, and avoids nonpartisan issues such as taxes, transportation, or health care. This year's legislative session saw several proposed bills of interest, if none where the FBA took a position for or against. Interesting examples from this year's session (several likely to be recurring issues addressed by the General Assembly in the coming years) were:

- HB 614 (similar to SB 474) Removes the requirement for an indigent defendant in civil actions to post an appeal bond in any civil case appealed from the General District Court. The bill also removes provisions of the Code allowing a plaintiff inan unlawful detainer case that has been appealed to the Circuit Court to request the judge to order a Writ of Eviction immediately upon entry of judgment for possession.
- HB 677 Requires any notice, summons, order, or other official document of any type that is required to be posted on or at the front door of a courthouse or on a public bulletin board at the courthouse to also be posted on the public government website of the locality served by the court or on the website of the Circuit Court Clerk.
- HB 782 Permits a plaintiff to nonsuit a claim appealed from a General District Court in a Circuit Court.
- SB 104 Except for aggravated murder of a law enforcement officer, eliminates all mandatory minimum sentences of confinement from the Code of Virginia.
- SB 143 Makes various changes to the procedures and jurisdiction of the Court of Appeals of Virginia, including (i) clarifying that an aggrieved party of certain pretrial orders may petition the Court of Appeals for review of such order and that such petitions shall be reviewed by a three-judge panel; (ii) providing that a party to an appeal that requests an extension for a filing deadline in the Court of Appeals must show good cause for the extension to be granted; (iii) clarifying that appeal bonds and security bonds are not required in criminal appeals; (iv) permitting the Court of

#### LOST TIME IS NEVER FOUND AGAIN



No, this is not an article regarding billable hours. Many lawyers do measure their professional success by the amount of hours we have worked because we are paid for our time. Unlike other professions, lawyers do not build physical structures, create art, or design technology, but we can leave positive tangible results behind us. To achieve those results depends on how you spend your time.

The Fairfax Bar Association's (FBA's) Young Lawyers Section recently hosted a happy hour to allow its members an opportunity to socialize with the Fairfax County Circuit Court judges. There was a good turnout both from the membership and the bench. I also attended, although my older age put me in the minority of the attorneys present. Those younger attorneys are at the start of their legal careers. They are trying to figure out the practice of law, e.g., how to deal with other attorneys, clients, and judges. In their personal lives some of them are single, some are in relationships, and others are raising young children. All of that means they are busy.

As those younger attorneys progress to the next stages of their careers, they will still be busy. I recently attended my 35th law school reunion at William & Mary. My classmates are now in the later stage of their legal careers and they still have a lot to do. With experience, we are more efficient in our practice of law, but we do not have the energy of a 25-year-old attorney who just passed the bar exam. We went through many stages in our careers and each one presented its own challenges, demands, and rewards. You never seem to have enough time.

Which brings me to the man I quoted in the title of this article—Benjamin Franklin. Some of you may have seen the recent PBS series on him or read Walter Isaacson's book, *Benjamin Franklin: An American Life.* Franklin never practiced law, but he seems to have done just about everything else. He was a printer, writer, media mogul who published newspapers in multiple cities (he was doing this three centuries before Mr. Murdoch), humorist, scientist, inventor, politician, diplomat, and of course, a rebel who joined others in putting their lives on the line for American independence.

While carrying out all of these roles, Franklin also made great contributions to his society. He founded the Library Company of Philadelphia, which allowed subscribers to borrow books. It still exists and you can check out its website at www.librarycompany.org. Franklin organized the Union Fire Company to bring order to what had been rather chaotic efforts from Philadelphia's citizens to put out fires. He pushed for police patrols and drafted the law to organize what would become the city police. With The American Philosophical Society, Franklin brought together scientists, mathematicians, and thinkers not just from Phennsylvania but from the other colonies as well. This was one of the many efforts by Franklin to bring the American colonies together not simply as British subjects, but as Americans. Franklin even worked to establish a volunteer Pennsylvania militia to aid in the defense against raiding privateers when most of the British regulars were fighting at the frontiers and not protecting the Delaware River. Franklin organized a lottery to raise money for the militia so it could buy artillery and equipment from New York, thus adding the title of "fundraiser" to his list of achievements. Such tasks are too much for any of us to achieve today, but you do not need to attempt this alone. The FBA provides each of you the structure and guidance to walk in Franklin's footprints. Even at the various phases of our careers, with all of the attendant time demands, we have the ability to do something that will improve the world around us.

#### 2022 LAW LIBRARY COMMITTEE

In recent weeks the Fairfax Public Law Library was visited by a paralegal certificate program's students and professor. Their professor shared our collection with the students in an important teaching moment for the paralegal program. When their tutorial was completed, the group spoke with our staff. They expressed their heartfelt thanks that we exist and that Northern Virginia enjoys such an important public resource. They also expressed concern that their options for legal research using both books and online resources are so limited.

The Law Library frequently receives thankful, relieved patrons who tell the same story: with the closure of the George Mason University Law School Library to the public, the Fairfax Public Law Library is the only substantial law library in Northern Virginia open to the public with a staff of superb professional law librarians. While the Arlington County, City of Alexandria, Prince William County, and Loudoun County courthouses provide law libraries, none compares to our Law Library and none is staffed by professional law librarians.

The three Fairfax County courts, serving the largest county population in the Commonwealth, should be supported by the largest law library—and they are. With the large printed collection and both law librarians and attorneys on our staff, we stand apart from the other courthouse law libraries. With what are regrettably dwindling financial resources for the law libraries serving the Northern Virginia cities and counties, the Fairfax Public Law Library remains preeminent.

#### The Evolving Role of Our Law Library

Our core function is to serve as a legal research resource for the bar and the public. With Internet research tools widely available to attorneys, our importance as a legal resource for the public and *pro se* litigants is reinforced every day. In this regard, the Law Library is a critical component of the Fairfax Law Foundation, the nonprofit charitable arm of the Fairfax Bar Association (FBA). Not a day goes by without a panicked *pro se* litigant coming into the Law Library needing a form or guidance in locating the proper resources to address their issues. While the lawyers on our staff never give legal advice, our resources enable the public and the bar to find the answers. We continue to be a respository of forms for the Circuit Court and support the General District and Juvenile and Domestic Relations District Courts with forms they do not provide in their Clerks' offices. Clerks and judges refer lawyers and *pro se* litigants to the Law Library on a daily basis.

One of the services the Law Library provides to the bar is transmitting difficult-to-locate cases and other legal resources by email. The importance of this remote service was reinforced by the inability or unwillingness of patrons to physically come to the Law Library during the pandemic. Our librarians are here to serve members of the bar, and email transmission of cases and other legal resources has become an important service for FBA members to count on.

The services the Law Library provides to the bar and the public continue to evolve. In addition to our many legal research tools, we provide numerous services to the public, the clerks of the court, court personnel, including interpreters, law defenders, and the judges.


Our computer lab, video teleconferencing equipment, and conference room provide access to justice for all those who we serve. We continue to host joyous occasions for persons who just received marriage licenses from the Public Services Office next to the Law Library to solemnize their vows in our conference room. And our conference room provides a convenient location for commissioner's hearings, interviews, remote hearing participation, and attorney/client meetings.

This past week we added a stand-alone scanner to the services we provide to the bar and the public. While this is a common piece of office equipment in a law office, there is nowhere in the courthouse that the public and members of the bar can scan a document and transmit it to an intended recipient. Frequently someone will come into the Law Library and urgently need to transmit a court order or pleading to someone. While the provision of document scanning services may seem prosaic, the Law Library's decision to provide scanning services created a logistical challenge. Additionally, the Law Library cannot assume responsibility for the safety and security of sensitive documents. We have met these challenges by making the scanner a stand-alone piece of equipment that is not connected to the courthouse network or the Internet, and will permit users to scan their sensitive documents into a thumb drive so they take immediate custody and control of their documents, which they can then privately transmit to the intended recipient.

#### JUVENILE AND DOMESTIC RELATIONS DISTRICT COURT

The Fairfax J&DR District Court Committee meets the second Thursday of each month at 12:30 PM. We have been meeting virtually since early in 2020 when COVID firt disrupted the courts. Starting in the fall of 2022, we are anticipating a hybrid meeting format where members have the option to attend virtually or in-person. We currently have 104 members. Our committee is comprised of members of the Bar who appear regularly for criminal, civil, and family law matters heard in the J&DR Court. Committee members are committed to sharing feedback with the Bench about the Court's operations and procedures, with the goal of helping to improve the public services provided by the J&DR. Court Committee members provide valuable insights and recommendations to the Bench each month and also volunteer their time to serve on subcommittees tasked with updating the *J&DR District Court Manual*, soliciting nominees for the Kassabian Award, and brainstorming ways to address the various challenges observed by both judges and practitioners.

Our monthly meetings are most often attended by current Chief Judge Sotelo, Judge Frieden, Judge Abejuela, Judge Petit, and Judge Cardoce. This committee would not be what it is without the dedicated participation of the judges who preside over cases in this court. The judges always welcome questions or concerns and are quick to get us answers and make changes needed to help maintain access to justice for all who have cases heard on the third floor of the courthouse.

Over the last year, our efforts as co-chairs of the J&DR District Court Committee have been largely devoted to helping the Bench continue to keep everyone informed about procedures and policies as the court had to keep adapting to changes needed due to the COVID-19 pandemic. We also were able to co-moderate a CLE on Trial Advocacy in the J&DR Court on March 30, 2022. Judge Frieden and Judge Abejuela, as well as Amy Jordan from the Public Defender's Office, Jenna Sands from the Commonwealth Attorney's Office, and Carly Anderson of Cooper Ginsberg Gray, PLLC, presented at this CLE and provided great information on how to effectively present both civil and criminal cases in J&DR Court.

In addition, the J&DR Court has continued to hire and train new clerks and implement new processes to help the Clerk's office run smoother under the direction of our new head Clerk of Court, Kristi Smith. We are grateful to have her regularly attend our monthly committee meetings to field questions about the Clerk's office operations. We would like to give out a shout to the Clerk's Office for being able to docket their 4,000+ backlog of cases due to COVID. We know it was no easy task. The court now has same-day docketing, which means you can leave court with a date certain for your hearing. Chief Judge Sotelo has also developed a program to transition over to electronic files to ensure that files are complete and that everything will be accessible to the judges and clerks in the courtroom.

We would like to recognize Judge Carr and those that assisted her in their efforts to bring the Hope Card Program to Fairfax County J&DR Court. Victims of domestic violence who have been granted a Protective Order, can now have a laminated wallet-sized card made that contains all the necessary information found on their Order.

Our committee wanted to extend a welcome and congratulate our two new judges on the Fairfax J&DR Bench. Their investitures were delayed due to COVID, but finally took place in February and April of 2022. In addition to their experience and expertise, Judge Cardoce and Judge VanLowe bring even more diversity to the Fairfax J&DR Bench. We also would like to extend our congratulations to one of our cochairs, Stephanie Smith, as well as Razan Fayez, a long-standing member and former chair of this committee, on being selected to serve as substitute judges.





Appeals to dispense with oral argument if the parties agree that it is not necessary; and (v) making consistent the grounds for seeking a delayed appeal in a criminal case in the Court of Appeals and the Supreme Court of Virginia. The bill additionally connects the unintentional elimination of reviews of interlocutory decrees or orders involving certain equitable claims from the jurisdiction of the Court of Appeals. The bill contains an emergency clause that is applicable only to this connection.

SB 208 - Provides that a person in a civil action shall be deemed to have standing
if that person has a cognizable interest in the outcome of the matter, which may be
represented by the ownership of an affected property interest or the suffering of an
injury unique to that individual.

The Fairfax Law Foundation, which is the charitable arm of the FBA, has numerous opportunities for you. The FBA Paralegal Section and the Foundation hold an annual book drive to provide books and journals, along with toiletries and sundries, for young people in residential correctional programs in Fairfax County. Look through your house and donate books. The Northern Virginia Pro Bono Law Center, supported by both the FBA and the Foundation, can supply you the opportunity to represent those who could not normally afford our services in areas such as landlord and tenant disputes, debtor's rights, lemon law, job discrimination, and unpaid wages. There is a "Wills on Wheels" program in which you can help low-income seniors and the disabled by drafting simple wills, durable powers of attorney, and advance medical directives. You can process an uncontested divorce or volunteer time to work on contested family law matters. Even if you have never practiced in these areas of law, the Pro Bono Law Center will provide you training and support. If you do practice in these areas, you can volunteer to provide that training and support to your fellow bar members. You do not have to quit your "day job" or abandon your families to participate. While you may feel that at this point in your life you do not have the time, you will find that you do have the time.
