James started his legal career at the law firm of Greenspun Shapiro (formerly Greenspun, Shapiro, Davis & Leary, PC), and has focused on traffic, criminal defense, personal injury and civil litigation. He opened his own firm in 2011 and expanded his practice to landlord/tenant disputes and other transactional litigation. He has federal litigation experience and has experience assisting small business clients in the formation, operation and dissolution of companies.

#### EXPERIENCE AND LEGAL ABILITY

James Davis has practiced in Northern Virginia and especially in Fairfax County since he began practicing law in 1998. Mr. Davis has extensive experience in both civil and criminal cases.
