

Benefits of Being a FBA Member

Stay informed on Local Bar and Court News: Being informed is critical to attorneys. One of the key benefits of being a FBA member is receiving weekly blast e-mails with information on law and procedural changes in the courts and upcoming events and programs. Opportunities to Network: With more than 2,000 active members including attorneys, paralegals, and judges in the region, the FBA provides social programs and events to help our members get acquainted with others in the local legal community. The FBA helps our members meet their CLE and ethics requirements by providing live CLE courses in the Fairfax County Courthouse or areas nearby for convenience. Use of Law Library: Get access to Westlaw, HeinOnline and Virginia Casefinder. Also, the library offers a meeting space up to 12 people (reservations are required) and Wi-Fi. The Fairfax Public Law Library resources include more than 35,000 books and legal periodicals as well as several public computer research terminals. The legal resources available in the law library are not available to the public at any other single location within the County of Fairfax.

Receive Membership Discounts: Receive reduced rates on CLEs, FBA publications, on FBA Membership Mailing Labels, and on FBA social events and luncheons.

Benefits through our Affinity Partners: FBA members receive discounts on a variety of products and services, including insurance plans, copier equipment and supplies, and more.
