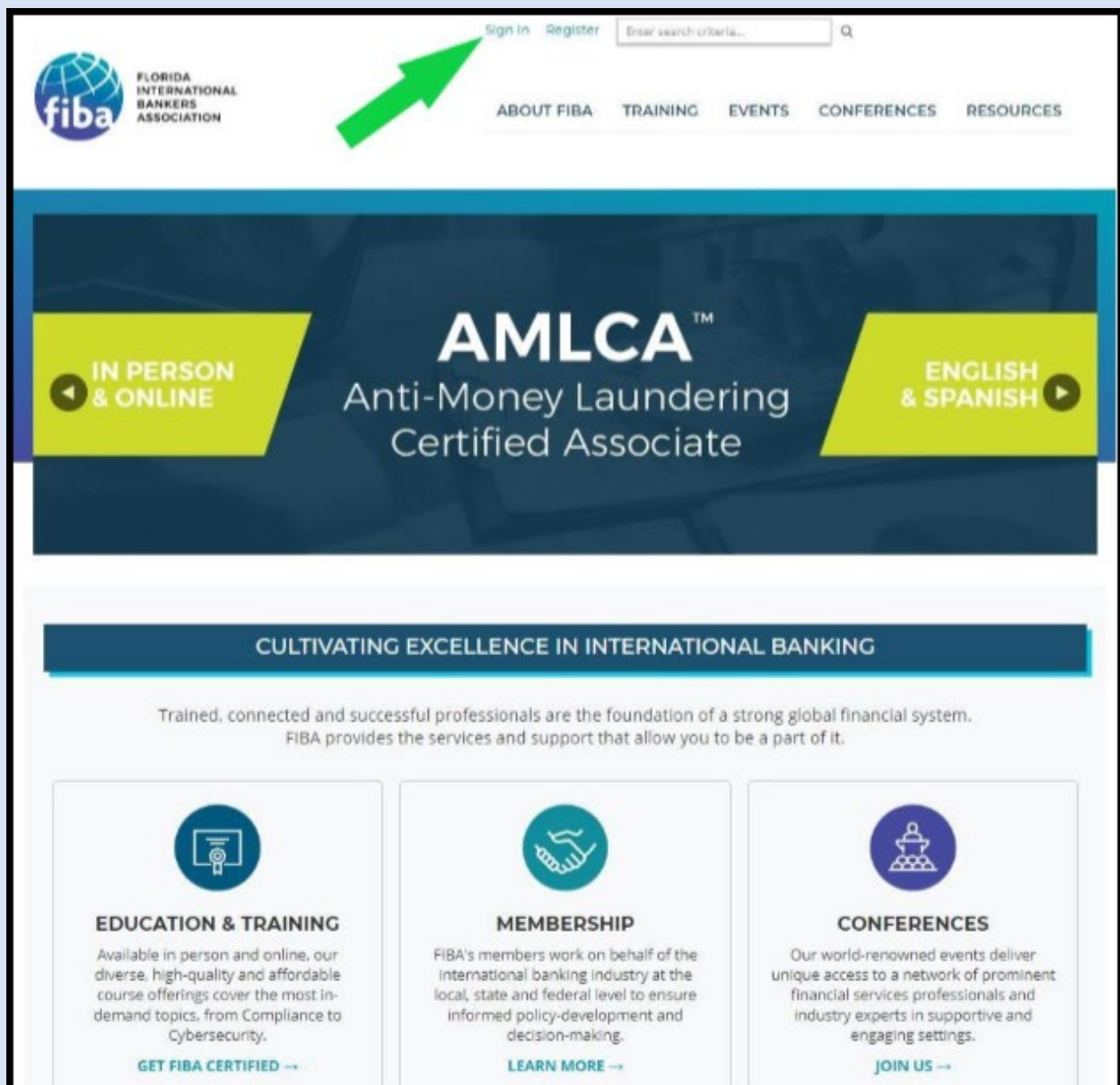



GUIDE TO DOWNLOAD DIGITAL CERTIFICATE ON THE FIBA PLATFORM






