A public hearing on the amendment is required if: <ol style="list-style-type: none"> <li>A) It adds an appropriation in excess of 1% of the total appropriations;</li> <li>B) Increases or decreases any appropriation by 10%;</li> <li>C) Increases the Amount to be Raised by Taxes by more than 5%, except for Emergency Temporary Appropriations.</li> </ol> </li> </ol>
