

<u>TITLE OF THE RESOLUTION</u>	Dedication by Rider.
<u>STATUTORY REFERENCE</u>	NJSA 40A:4-39
<u>INSTANCE WHEN YOU WOULD TYPICALLY USE</u>	To dedicate through the budget, revenues that are not subject to reasonably accurate estimation in advance or are restricted in use by law or regulation. Typical uses are dog license funds, bequests, escheats and gifts, Developer Escrow Funds, Reserves for snow removal and accumulated leave.
<u>LIMITATIONS</u>	May be dedicated by State Statute, if not, requires written approval of the Director, Division of Local Government Services. Funds must be kept segregated in a trust fund.
