Management Company Annual Dues - \$335

Management Companies with apartment communities in the Nashville listed MSA are required to report/pay dues on all of their apartment communities with 50 or more apartment units.

Management Company Annual Dues - \$510

Management Companies that have apartment communities with under 50 units in the listed Nashville MSA are required to pay \$510.

- All membership dues are pro-rated depending on the month you join GNAA.
- All membership applications are presented to the Board of Directors once a month for approval.

- **All applicants will pay \$50 for benefit of full GNAA Statistics access in 2018.**
- **All membership applicants must pay a \$25 nonrefundable administrative fee.**

Account Agreement

We realize that the Greater Nashville Apartment Association is a non-profit organization that exists for the purpose of its members. Therefore, we agree to the timely payment (within 30 days of receipt of invoices) of all balances due to GNAA.

Membership automatically renews annually and membership dues are paid on an annual basis. Members may terminate this agreement by giving at least 30 days prior written notice and notifying GNAA by December 1st. However, if a member is dropped from the roll for non-payment of dues, monies or any other billing, the entire annual dues and billing shall remain due and payable to GNAA. Dues are non-refundable for early termination.

Additionally, if litigation becomes necessary to collect any balance due, you agree to pay any reasonable attorney's fee in addition to court cost and all cost of collection.
