### Contractor Membership: see chart below

To be classified as a contractor member, your company must undertake contracts to perform civil construction services. Examples of these jobs include but are not limited to the construction, maintenance, and demolition of roads, bridges, waterworks, sewer, ports, and airports. Dues are determined by the volume of public or private work performed in the previous year. See chart below.

### Associate Membership: \$1,000

To be classified as a small business member, you are required to be brought in through Kim Sturgis, Director of the Small Business Program and approved by the Small Business Committee. This membership applies to both contractors and associates.
