Thank you for your continued support of the Human Resource Association of Palm Beach County (HRPBC) by maintaining your membership with us. As we have previously communicated, the 2018 membership Dues will be waived as long as the member designates HRPBC as their primary chapter. If not then, there will be a \$45 renewal fee.

HRPBC is a 100% SHRM Chapter which means that all of our members must also be members of the Society of Human Resource Management. Please be sure to maintain your SHRM membership throughout 2018 to avoid discontinuation of your HRPBC member benefits. While members are permitted to be members of multiple SHRM-affiliated chapters at the same time, an individual may only designate one as the “primary” chapter. By designating, or continuing to designate, HRPBC as your primary chapter, you will be counted by SHRM as “one of us”, belonging to one of the largest SHRM-affiliated chapters in Florida. Additionally, because SHRM, in its discretion, may provide certain benefits or financial support to chapters based the number of primary members, selecting HRPBC as your primary chapter will demonstrate your support of HRPBC to SHRM.

Membership shall be limited to:

- Practitioners of human resource management at the exempt level for at least three (3) years;
- Faculty members holding an assistant, associate or full professor rank in human resources management or any of its specialized functions at an accredited college or university and have at least three (3) years of experience at this level of teaching;
- Full-time consultants with at least 3 years' experience practicing in the field of human resources management;
- Individuals certified by the Human Resource Certification Institute; or
- Full-time attorneys with at least three (3) years' experience in counseling and advising clients on matters relating to the human resource profession.
- Only professional members of the Chapter may vote and hold office.
- Those who designate HRPBC as their primary chapter are counted by SHRM as having associated with HRPBC, which may provide the chapter with additional financial support from SHRM to assist in providing quality programs and networking opportunities to members. *There are no membership fees associated with this membership type and membership will run calendar year (January 1-December 31).*

Professional Non-Primary

Membership shall be limited to:

- Practitioners of human resource management at the exempt level for at least three (3) years;
- faculty members holding an assistant, associate or full professor rank in human resources management or any of its specialized functions at an accredited college or university and have at least three (3) years of experience at this level of teaching;
- full-time consultants with at least 3 years' experience practicing in the field of human resources management;
- individuals certified by the Human Resource Certification Institute; or
- Full-time attorneys with at least three (3) years' experience in counseling and advising clients on matters relating to the human resource profession.
- Only professional members of the Chapter may vote and hold office.
- Individuals who have designated another local chapter as their primary chapter, or who do not wish to designate any chapter as their primary chapter, pay dues of \$45 for each calendar year (Jan 1 through Dec 31) .

Associate Primary

Membership shall be limited to:

- Individuals in non-exempt human resource management positions as well as those individuals who do not meet the professional member category, but who demonstrate a bona fide interest in human resource management and the mission of the Chapter, including national affiliate members.
- Associate members may not vote and may not hold office in the Chapter.
- Those who designate HRPBC as their primary chapter are counted by SHRM as having associated with HRPBC, which may provide the chapter with additional financial support from SHRM to assist in providing quality programs and networking opportunities to members. *There are no membership fees associated with this membership type and membership will run calendar year (January 1-December 31).*

Associate Non-Primary

Membership shall be limited to:

- Individuals in non-exempt human resource management positions as well as those
- Individuals who do not meet the professional member category, but who demonstrate a bona fide interest in human resource management and the mission of the Chapter, including national affiliate members.
- Associate members may not vote and may not hold office in the Chapter.
- Individuals who have designated another local chapter as their primary chapter, or who do not wish to designate any chapter as their primary chapter, pay dues of \$45 each calendar year (Jan 1 – Dec 31).

Student

Membership shall be limited to:

- Individuals who are actively enrolled in human resources degree programs at the college or university level. Student members may not vote and may not hold office in the Chapter. Student members must be national student members of the Society for Human Resource Management (SHRM).
- The only costs associated with membership for Student membership is maintaining membership with SHRM.
