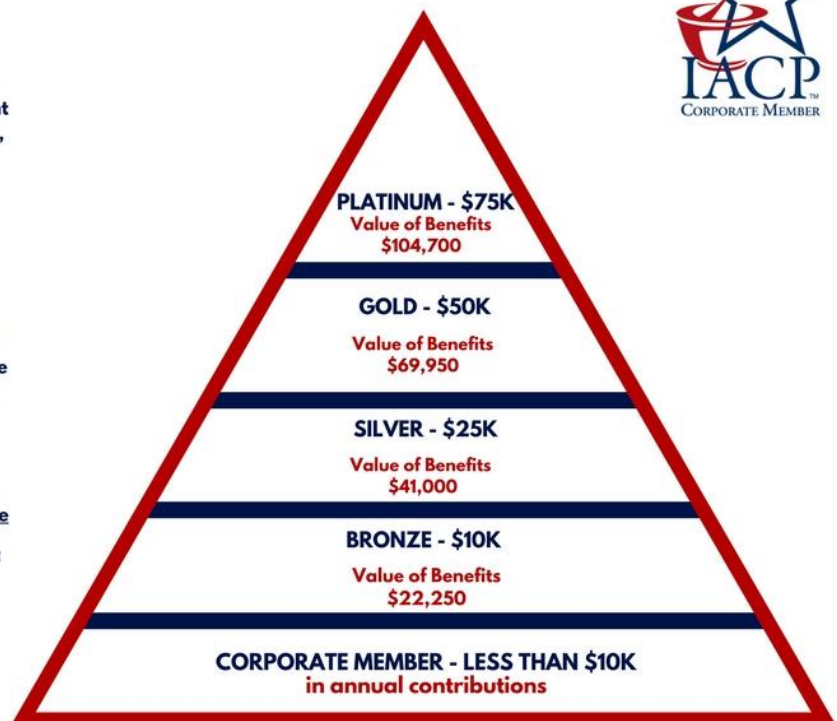
## **IACP Corporate Member Tier Program**

- In determining tier designation, non-monetary (in-kind) donations can be considered at reasonable market value determined by IACP. Please note that IACP has the authority to designate a value to the donation and that this value will be based on reasonable market values. Non-monetary donations may include, but are not limited to, travel miles for the IACP EVP or other IACP staff; building donations to IACP for education events; and exhibiting booths at other organization's events.
- Due to laws and regulations, IACP cannot include donations to the IACP Foundation or IACP COMP PAC. These donations must be considered only for those entities, and please stay tuned for our big COMP PAC Tiers launch.
- The IACP Corporate Member category placement is determined by the previous year's contributions to the Academy.
- IACP reserves the sole right to change the Corporate Member Tiers Program, benefits, and details at any time.
