


#### Yoga practice is on the rise

2007: 6.1%


2012: 9.5%


## Yoga research is growing

## **Intervention Description Quality**

- Without an accurate description of interventions, clinicians and patients cannot reliably implement interventions
- Researchers cannot replicate research findings
- TIDieR reporting guidelines will improve the quality of yoga intervention reporting applies across all study designs.

# Health Research Reporting Guidelines (HRRGs)

# Health Research Reporting Guidelines (HRRGs)

"High-quality research reports contribute to more efficient translations of research findings into clinical practice and help advance scientific knowledge and patient care."

## Recent History of HRRGs

- 1962: The FDA required pre-approval drug and medical device testing for safety and efficacy. This led to the use of controlled clinical trials for pre-approval.
- 1980s: *The Lancet* editorial on meta-analysis of aspirin for cardiac risk reduction in post-MI patients
- 1996: First HRRG was CONSORT
- 2006: The EQUATOR-Network: international library for reporting guidelines
- 2014 TIDieR guideline: British Medical Journal

# The EQUATOR Network

The EQUATOR Network (Enhancing the **QUA**lity and **T**ransparency **O**f health **R**esearch) is an international initiative that provides an up-to-date centralized resource for:

- Researchers and scientists reporting research
- Peer reviewer assessment of manuscripts; and
- Editorial evaluation of submitted manuscripts

# Background

#### **Aim**

 Develop reporting standards for clinical yoga research, in line with the Template for Intervention Description and Replication (TIDieR) guidelines

# Design

#### Design

- Criteria for analysis, consensus, and termination based on previous Delphi studies
- Criteria for consensus and analysis determined a priori by the steering committee via protocol
- IRB approval

#### Research Methods

#### Delphi

- Yoga research experts (with consent)
- 3 rounds to reach consensus on draft TIDieR guidelines
- Online survey via SurveyMonkey HIPAA compliant.
- Analysis for consensus at each Round using descriptive statistics (median and IQR)

## Research Methods

- Consensus meeting
- Finalize guidelines
- Publication and dissemination
- Guidelines utilization


# Guidelines Follow-up
