

**On March 26, 2020**, EPA issued a [guidance document](#) outlining temporary policy regarding the enforcement of environmental legal obligations for noncompliance resulting from the COVID-19 pandemic. Similarly, many state environmental agencies have also issued their own temporary enforcement discretion guidance, some expanding the EPA's discretion while others are warning that compliance is still required and violations will be pursued. Below are links to the states' guidance, which will be updated as more information becomes available.

**On April 17, 2020**, EPA issued the [interim final rule](#) on Continuous Emission Monitoring; Quality-Assurance Requirements During the COVID-19 National Emergency to temporarily amend the Part 75 emission monitoring and reporting regulations for the Acid Rain Program, Cross-State Air Pollution Rule (CSAPR), and the NO<sub>x</sub> SIP Call. The temporary amendments are designed to reduce the COVID-19 exposure risk to power plant and other essential personnel. Under the temporary rule, power plant operators that cannot complete a required quality assurance activity due to travel, plant access, or other safety restrictions implemented to address the current COVID-19 national emergency can continue reporting valid, measured data.
