Ben Binford was a very active member of the San Antonio Insurance community. He served as the IIASA president in 1968 -1969. He also served as the President of the IIAT in 1974 and was awarded their highest honor – The Drex Forman Award in 1978.

Ben passed away in 1978 and in honor of his service and contributions to our local association and to the Insurance Industry as a whole, the Independent Insurance Agents of San Antonio created the Ben Binford Award in 1982.
