THE COMMUNITY

Channahon, Illinois is located 45 miles southwest of downtown Chicago. Interstate 55 passes through the community, and Interstate 80 is two miles to the north. The City

of Joliet is contiguous to the east; Village of Minooka and City of Morris to the west; City of Wilmington to the south; and the Village of Shorewood to the north.

Channahon is a Native American name signifying 'The Meeting of the Waters". The confluences of the Des Plaines, DuPage and Kankakee Rivers form the Illinois River in the area. The community grew in the second half of the 19th century with the construction and operation of the Illinois and Michigan Canal, now owned and managed as a recreational asset by the Illinois Department of Natural Resources. Additional IDNR and Forest Preserve District of

Will County lands and facilities are also located within the district.

The district serves a residential population of approximately 19,000 residents, primarily in the northern region of the district's 44 square mile jurisdiction. The district serves all of the Village of Channahon in Will and Grundy Counties; the portions of the Village of Minooka in Will County; and remaining unincorporated areas in Channahon Township. Median household income is approximately \$89,900.

Residential growth is returning to the community, with 106 new single family housing starts in the Village of Channahon in 2017 and a higher amount projected for 2018.

The primarily southern region of the district is home to many international companies including ExxonMobil, Aux Sable Liquids, Dow Chemical, and INEOS Styrolution. Their stable employment base and high levels of real estate equalized assessed valuation are both solid assets to the park district.

CHANNAHON PARK DISTRICT

The park district was formed in August of 1971. The district currently employs 23 full-time, 115 part-time, and over 200 seasonal staff members.

Major programming locations include Arrowhead Community Center, which also houses the district's administrative offices; Heritage Crossing Field House, a cooperative venture with Channahon School District 17; Skateland Recreation Center; Tomahawk Aguatic Center, a 890-person bather load outdoor aquatic facility; and Heritage Bluffs Public Golf Club, a nationally recognized 18-hole course on 166 acres.

In addition to Heritage Bluffs, the district owns 441 acres at 30 locations. There are four future parks for development. Over 10,000 program registrations were processed in 2017, with over 1,100 programs offered.

The district works closely with the People for Channahon Parks Foundation. The Foundation has generated \$1.3 million over the last four years to support the development of Arroyo Trails, a new nature based park to bring children and families back to nature. An additional \$250,000 has been raised

to support park district and other community recreational needs.

opportunities and experiences The park district is known for its investments in community partnerships. From Heritage Crossing to volunteer placements, the district works with every local government in the area and committed residents to expand services.

- * Possess excellent oral and written communication skills with ability to communicate effectively with all types of individuals.
- * Active community leadership with knowledge of the importance of involving communities in collaborative processes for park planning and the belief in the strength of community involvement and participation, including volunteerism.
- * Preferred management style that is collaborative and emphasizes team management.
- * Knowledgeable of park and recreation issues, trends, personnel management, creative financing, marketing and public relations.
- * Comprehensive planning skills and experience. Ability to assess community needs, research trends and innovative concepts as they apply to improvement of the agency operations and long-range planning.
- * Demonstrated success in administration and budget management. Must have experience in the creation of a sound fiscal program including: capital projects, budgeting, forecasting, development of projects through the referendum process, and other alternative funding sources; e.g. foundations/federal/state grants and enterprise operations.

Applications should be marked Personal and Confidential. All applicant packets must be received by September 28, 2018 and must contain the information below in order to meet the Board consideration. All documents (other than education credentials) must have a left margin of 1.5 inches. Each numbered item below needs to be on a separate page. Please do not bind or staple.

- 1) Formal letter of application indicating reasons you desire to be a candidate.
- 2) Current resume needs to include, but not be limited to, employment history, duties, number of employees supervised and budget amount managed.
- Complete list of accomplishments/completed projects.
- Provide at least 3 **CURRENT** letters of recommendation. These written references ideally should include a balance of former employers, employees and board members.
- 5) You must also supply 3-6 **PROFESSIONAL** references with complete names, addresses and phone numbers. These references need to be different from those providing letters of recommendation and will be contacted by the Illinois Association of Park Districts upon receipt.
- 6) Typewritten responses to the following management questions. Please limit your responses to one page per question.
 - a. Describe your management style.
 - b. State and discuss your philosophy of parks and recreation.
 - c. What issues do you consider to be critically important to the park and recreation field today?
 - d. If given the opportunity, how will you attempt to resolve these issues?
 - e. If you were chosen for the position, what steps would you take as the district's new leader in your first 120 days?
- 7) Salary history for the past 5 years.
- 8) Complete set of up-to-date credentials which include legal proof verifying educational degrees. Transcript or copy of degree is acceptable.
- Written permission to contact past employers and written permission to have a criminal background check.
