



Frequently Asked Questions

What are the registration rates and deadlines?



Includes 5 hours in-person CLE plus 5 hours of on-demand CLE; lunch; break station and snacks, and a personal care kit

- Members: \$150
- Sustaining members: \$135
- Members admitted for less than 5 years: \$75
- Law students \$75
- Judges: \$75
- Affiliate members: \$75
- Non-members: \$350



Includes 10 hours on-demand CLE and a goodie box mailed to your home (if registered by Sept. 8). Be sure to indicate your preferred location for the goodie box to be mailed to when registering.

- Members: \$35
- Non-members: \$150

Registration deadline: Oct. 4

Bonus CLE: Attendees who register before Sept. 8 will receive 3 hours of Bonus CLE!

Session recordings: All attendees (both in-person and virtual) will receive the recordings from all Annual Meeting sessions.

Will I receive CLE credit for attending the Annual Meeting?

Yes! If you attend the Annual Meeting in-person, you will receive live CLE credit. If you attend virtually (either via the real-time live stream or by watching the on-demand versions of programs after the event has concluded), you will receive distance CLE credit. As a reminder, the total number of distance CLE hours allowed for attorneys and judges has been increased [per Supreme Court order](#).

How do I access the program materials?

Program materials will be available electronically and emailed to attendees prior to the Annual Meeting.

How will I access the Annual Meeting CLEs, House of Delegates Meeting and Assembly Meetings virtually?

Instructions on how to access any of the Annual Meeting events virtually will be emailed to attendees prior to the Annual Meeting.

When will I have access to the virtual event platform?

All registrants will receive an email notification, when the platform is available in late September.

Can I register for the Annual Meeting on-site?

Due to this year’s Annual Meeting having capped attendance, registration will not be allowed on-site.

Can I switch between CLE tracks on-site?

Due to safety protocols and capped attendance, this will not be allowed. Additionally, members will have assigned seating during the CLE sessions.

When is the House of Delegates Meeting, and do I need to register for it?

Who are members of the House of Delegates?

Each Indiana county has at least one delegate and alternate delegate to represent their county at the annual House of Delegates meeting for a one or two-year term. Additional delegates are authorized at a rate of one delegate per every 50 voting members in each county.

Additionally, the following are ex-officio voting members of the House of Delegates:

- ISBA past presidents
- Past chairs of the House of Delegates
- Indiana members of the House of Delegates of the American Bar Association

- A member of the Supreme Court of Indiana to be selected by that Court
- A member of the Court of Appeals of Indiana to be selected by that Court
- The president of the Indiana Judges' Association
- The deans of the accredited law schools located in Indiana
- The Attorney General of Indiana
- Chairs of ISBA sections
- Chairs of ISBA standing committees
- Such representatives of other professional legal organizations as may be designated from time to time by the House of Delegates

How do I request CLE credit for attending the Annual Meeting?

All annual meeting registrants will submit their CLE form electronically. A link to the CLE form will be emailed prior to the Annual Meeting. Please note: CLE credits will be filed only for paid Annual Meeting registrants.
