Highlight of Accomplishments

- ❑ At its July 15, 2023, meeting, the ISBA Board of Governors approved a recommendation to amend its current policy regarding paralegal membership so that five years of work experience will qualify individuals for membership, as long as the prospective paralegal members have an attorney sponsor and meet the definition of a paralegal, without requiring education or certification credentials.
- ❑ Also, this proposal included an amendment to reduce CLE requirements for maintaining membership in ISBA. CLE requirements for paralegal members now consists of a minimum of 3 hours, including 1 hour of Ethics, per year. Bottom line: We're getting rid of the three-year cycle concept and tracking CLE on an annual basis.

Highlight of Accomplishments

- The Agricultural Law Section has been somewhat dormant since covid hit two years ago. This past year the Section has begun to revive the Section. New Officers and Council members have been elected. One CLE was held in August with another CLE planned in November of this year. CLE

EPA case in which the United States Supreme Court helped determine what is, and what is not, wetlands and waters of the United States. EPA is scheduled to have new regulations out for comment by the end of September 2023, which regulations will also be discussed.
- Future CLE's will be discussed and planned at the next Section leadership meeting.

- The Agricultural Law Section was not active during the last Indiana legislative session but plan to have regular reports to Section members during the next session as to legislation that affects agriculture.

- Committee members review and investigate applications from individuals seeking assistance from the Fund.



2022-2023 CFAF Payments Overview

- 28 applications resolved: 7 approved, 11 denied
- \$59,030.18 total in payments *approved to be paid*
- \$650.00 to \$15,000.00: range of payments approved
 - Average Payment: \$8,225.64
 - Median Payment: \$8,432.88
- Note: *Not all payments have been made. ISBA is waiting for certain documentation required from some applicants.*

- The executive committee decided to create new scholarships for section members to attend the ICLEF annual two day family law institute and decided to name the scholarships after practicing family law attorneys who have provided substantial time and energy related to our section, as well as mentoring and educating family law attorneys.

GAL GUIDELINES FOR CIVIL FAMILY LAW CASES

*The Family and Juvenile Section is putting on its first [free!] CLE to our Section members and GALs on Tuesday, September 26, 2023, during the lunch hour via Zoom on the new proposed GAL Guidelines. The CLE will be taught by Debra Dubovitch who was on the Indiana Family Law Taskforce and a drafter of the proposed Guidelines, and moderated by the section Chair, Jill Goldenberg.

*As of the date of submission of this Report, over 120 participants are registered!



Legislative Activity

There was a lot of work in legislative activity in 2023. Here are some highlights

- (i) Trial Rule 74 – We submitted our public comment
- (ii) HB 1296 – Presumptive joint physical custody. The Section worked on this; however, it did not make it through the session. We have already had at least two summer studies on this concept.
- (iii) HB 1009 – Drew Soshnick testified on the Section's behalf and as a result of the testimony, the bill was amended. The bill no longer contained a provision about child support from inception which would have had some significant ramifications including with Title IV-D.
- (iv) HB 1172 – regarding the appointment of counsel in TPR cases and CHINS cases pending over 15 months, adoptions and guardianships for 12 year olds and up: The Chair met with the Chair of the children civil rights committee; however, ultimately this did not proceed.

Additionally, the Real Property and Probate Group created a new legislative proposal about court-ordered real property disposition. I.C. 31-15-7-4.5 that was presented to our Section. We worked on a redline to this proposed legislation, and, after approval from the council, submitted it back. They did not accept all and made many more revisions, but the Section ultimately will not oppose this legislation when it gets introduced.

Presumptive joint legal custody will be introduced in the next session so the Council will address this new proposal upon receipt.



Social opportunities

- We held our second annual summer social at Spencer Farm Winery in Noblesville, Indiana on Friday, June 30, 2023. It was free to members plus one guest, and the judiciary.
- The venue is indoor/outdoor and we provided our guests with a complimentary wine glass they could use for a free glass of wine, tokens for wine tasting, great food and cookie favors. We also did a drawing for a Spencer Farm Winery Gift Basket. There was a live band there that night following our event if people wanted to stay.
- We had great attendance but decided we needed to more closely scrutinize our date next summer so as not to conflict with a holiday weekend as we did this past year (July 4).



Alternative Education Opportunities

- We provided a Town Hall Meeting for the entire Section on June 20, 2023, where Magistrate Drew Bloch addressed questions and offered insight into the new proposed Indiana Child Support Guidelines. It was well-attended and we had good feedback.
- We continue to have a committee that publishes updates on family law case law to the Res Gestae.
- We continue to support a community list-serv to provide our section members a forum to ask questions and seek assistance in their day to day family law legal matters



Scholarships & Awards

- We awarded five scholarships to the ISBA Small and Solo Firm Conference in 2023. We have renamed these scholarships in honor of Magistrate Deb Shook and intend to award these scholarships in Magistrate Shook's honor in 2024 and future years.
- We sponsored three dinners for recipients to attend the Young Lawyer Section Etiquette Dinner.
- We voted to present the 2nd annual Nanette K. Raduenz award to Magistrate Drew Bloch, and also to award same at the judicial institute in French Lick in September.
- We added three new scholarships. We decided to award three members of our section the ability to attend the annual ICLEF Family Law Institute. We intend to name these scholarships after Andrew Mallor, Debra Dubovitch and Drew Soshnick, Section Members who have impacted our Section and the family law bar through their mentorship, education and collegiality to the bar.

Looking to the Future

On our agenda for 2024 is revising our By Laws and amending our slating process at which time we will slate new members for 2024

Additionally on our agenda is creating a section wide/state-wide service opportunity in an effort to bring the section closer and join forces for the common good. Highlight of Accomplishments

- The committee helped place over 80 articles in *Res Gestae* this year.
