Adler Attorneys Fee Agreement

Attorney Fees

I agree to pay costs/expenses for the Description (matter) (Matter Type (matter)) matter, plus the following attorney fees:

Flat Fee: \$AMOUNT. Payment is due upon signing. One-half (1/2) is due when this Fee Agreement is signed and is nonrefundable. The remaining one-half (1/2) is due at the completion of the matter. This Agreement becomes effective on the date it is signed by all signers below.

Hourly Fee: billed at the Hourly Rates shown below, invoiced monthly. This Agreement becomes effective on the date it is signed by all signers below and after any Retainer is paid.

Retainer: \$AMOUNT.

A Retainer is an amount paid by you to Adler Attorneys. This amount allows us to "get started" on your case. The Retainer is deposited into the firm's trust account and applied to your matter(s) as Invoices become due. Any Retainer amount that is not used for your matter(s) will be refunded.

Combination Fee: This is a combination Flat Fee and Hourly Fee.

For a Combination Fee, you will pay a Flat Fee of \$AMOUNT. This Flat Fee payment is earned in full when it is paid to us. This Flat Fee will pay us to get your case to a certain point Scope of Representation (matter). The Flat Fee payment is not refundable and is the Minimum Fee we will earn for your case.

If work beyond that point is needed, the case will convert to an Hourly Fee and an additional Retainer may be required to complete your case.

Contingent Fee of 1/3 (33.33%) of all sums recovered plus costs/expenses, if the case is settled without trial. The contingent fee is 40% of all sums recovered if trial is required, even if the case is settled right after the trial starts. This Agreement becomes effective on the date it is signed by all signers below.

Hourly Rates
