1. **PREAMBLE**

IoDSA, as a SAQA recognised professional body, is required to allow candidates participating in the IoDSA designation assessment processes to appeal the outcome of any of the components of the assessment process.

2. **POLICY PROVISIONS**

Candidates are able to appeal the outcome of each component of the assessment process comprising the Certified Director® or Chartered Director SA® certification programme. Where applicable, the candidate will be required to pay the prescribed fee. Component decisions that can be appealed include:

Registration Outcome

An applicant is able to appeal the unsuccessful outcome of their application for registration or reinstatement of the Certified Director or Chartered Director SA designation.

Assessment Outcomes

- Portfolio of experience a candidate who is deemed Not Yet Competent (NYC) during the portfolio assessment is able to appeal this outcome.
- Examination a candidate who has failed the examination and oral supplementary examination (where applicable) is able to appeal this outcome based on provisions in the IoDSA Certification Examination Policy.
- Peer review a candidate who has not been recommended for certification by the Interview Panel is able to appeal this outcome.

It is important, where possible, that the appeal is assessed by individuals who were not part of the initial assessment.

If the appellant is not satisfied with the outcome of the appeal, they are able to elevate the appeal to a higher structure as per table below:

Note:

- Initial assessment is the person or committee that performed the first assessment
- Appeal structure is the person or committee to whom the appeal is addressed
- An independent consultant may be contracted to evaluate appeals where conflicts of interest are perceived or identified, the cost of which is to be borne by the applicant

3. **PROCESS**

- The appellant submits the appeal within the prescribed time period in writing to <u>certification@iodsa.co.za</u> and address it to the relevant appeal structure. Where the outcome of the POE or the Exam is appealed, the prescribed appeal fee must be paid before the appeal will be administered;
- The appeal will be considered by the relevant structure/person and a recommendation made within 30 calendar days from submission and in writing to the appellant; where the 30 calendar days requirement cannot be met, the appellant will be informed accordingly;
- In the event of a successful appeal decision related to the POE or the Exam, 50% of the appeal fee will be refunded;
- All appeals will be presented for recording at the Certification Committee meetings.
