IPCPR is a not-for-profit trade association organized as the advocate for the independent retail tobacconist and recognized as the "Voice of Authority and Reason" on premium tobacco related issues. IPCPR provides its members with assistance to fight draconian and onerous tobacco legislation, and brings retailers and manufacturers together in mutually advantageous business relationships.

MEMBERSHIP QUALIFICATIONS

In order to be eligible for membership with IPCPR a retail member must meet **ALL** of the following criteria.

- Be a licensed retailer selling premium pipes, pipe tobacco, cigars and related accessories,
- Possess all state required permits and licenses, including sales tax and OTP (Other Tobacco Products) license if required, for the retail sale of tobacco and related products,
- Maintain the primary source of business as the retail sale of tobacco and related products,
- Operate a brick and mortar retail store in a location with retail zoning,
- Be accessible to the general public during normally accepted retail business hours,
- Have exterior signage with the store name visible to the passing public.

IPCPR membership is valid for a single store only (additional membership applications may be submitted for additional store(s) if desired).

Important Note: Online retailers, mail order-only operations, cigar clubs, and private individuals are not eligible for IPCPR membership.

MEMBERSHIP APPLICATION REQUIREMENTS


To apply for membership with IPCPR, a retail store must submit **ALL** of the following with this Membership Application:

- Copy of retail sales tax license
- Copy of tobacco license(s)
- Photograph of the outside of the business, clearly showing the store front and sign
- Signage clearly visible by the passing public
- Photographs of the inside of the business, clearly showing tobacco and premium cigar displays
- Check for \$395

*Incomplete applications or applications that do not meet **ALL** of the required criteria will not be considered for membership.*
