

QUÉBEC'S REGISTRATION RATE STRUCTURE

Effective date : January 1, 2013

TRUCK OR TRUCK TRACTOR

Truck:

If the vehicle is a truck having:

UNLADEN (TARE) WEIGHT	REGISTRATION FEE
3,000 kg or less (6,614 lbs or less)	\$ 194

Truck or tractor:

If the vehicle is a truck or a truck tractor having a tare weight of over 3000 kg (over 6,614 lbs) :

1. Determine the **TOTAL COMBINED NUMBER OF AXLES** (power unit axles + trailer or semi-trailer axles).
2. Locate TOTAL COMBINED NUMBER OF AXLES in column A and use the corresponding fee in column B.

Column "A" AXLES	Column "B" REGISTRATION FEE CAN \$
2 axles with tare weight over 3,000 kg (over 6,614 lbs) but not over 4,000 kg (not over 8,818 lbs)	\$ 426
2 axles with tare weight over 4,000 kg (over 8,818 lbs)	\$ 742
3 axles	\$ 1,286
4 axles	\$ 1,887
5 axles	\$ 2,303
6 axles and more	\$ 3,155

3,001 TO 8,000 KG (6,615 TO 17,637 LBS)	\$ 484
8,001 TO 10,000 KG (17,638 TO 22,046 LBS)	\$ 650
10,001 KG AND MORE (22,047 LBS AND MORE)	\$ 808

WRECKER (Towing)

UNLADEN (TARE) WEIGHT	REGISTRATION FEE CAN \$
1 TO 3,000 KG (1 TO 6,614 LBS)	\$ 194
3,001 TO 8,000 KG (6,615 TO 17,637 LBS)	\$ 348
8,001 TO 10,000 KG (17,638 TO 22,046 LBS)	\$ 464
10,001 KG AND MORE (22,047 LBS AND MORE)	\$ 607

QUEBEC FINAL FEES ARE ROUNDED OFF AS FOLLOWS :

- (1) where the amount is less than \$10, to the nearest multiple of \$0.05;
- (2) where the amount is equal to or greater than \$10 but less than \$25, to the nearest multiple of \$0.10;
- (3) where the amount is equal to or greater than \$25 but less than \$100, to the nearest multiple of \$0.25;
- (4) where the amount is equal to or greater than \$100, to the nearest multiple of \$1.00.

An amount that is equidistant from 2 multiples is rounded off to the greater thereof.
