#### By Laws: Firm Members:

Those Firms who have Professional Members who are actively engaged as consultants in the field of Land Surveying in Indiana are eligible for Firm Member status. The dues for a Firm Member shall be calculated on the basis of the number of personnel, including principals, registered surveyors, designers, draftsmen, technicians, (excluding part-time employees), clerical and all other employees on the firm's payroll for the past calendar year. In the case of a multidiscipline Engineering-Land Surveying firm, the prorated portion of personnel concerned with, or in general support of the Land Surveying function shall be counted.
