2019 ISTR Asia Pacific Conference theme:
Shifting Sands? The Challenges of Regulatory Change and Its Impact on the Third Sector Environment in the Asia Pacific Region

For third sector researchers, contemporary Asia presents somewhat of a paradox. Many of the countries in this enormous region of the world are home to a vibrant civil society or third sector, engaged in a wide range of activities from social services, to advocacy, to budding social entrepreneurship. Yet in many countries in Asia, governments are expanding their oversight and/or control over the activities of advocacy groups and organizations engaged in independent services and support through tighter regulatory controls and scrutiny. This phenomenon is evident in countries as diverse as India, China, Nepal, Malaysia, Thailand, and Vietnam. There are, of course, other ways in which the state intervenes, controls and even collaborates with third sector organisations, including providing tax or regulatory incentives to engage in different forms of community service or corporate social responsibility, and in more advanced economies there has been a significant shift in funding of specific service delivery away from the state to the third sector.

The suggested paradox lies in the evidence that while governments are acting to control the advocacy role of third sector organizations, they are going an extra mile to create supportive environments for the enterprising and service delivery role of such organizations. In addition, the corporate sector is investing heavily in social entrepreneurship in the region. This complex set of relationships between the state, the market and the third sector offers an important focus for this conference. However, we are also interested in drawing in the extremely wide breadth of research conducted in this highly interdisciplinary, dynamic field of research and would welcome all contributions.

The 2019 Asia Pacific ISTR conference is an opportunity to showcase exciting new practice developments and research that seek to establish sustainable roles for third sector organizations and help them to cope with challenges in the many diverse countries that make up the region. We are very keen to see a wide range of papers that encompass applied

research, practice research and theoretical advances and explorations in all aspects of this field.

SUBMISSION AND SELECTION OF ABSTRACT

Proposals of Abstracts are welcomed for Paper Sessions and Panels (pre-arranged) of 3-4 papers are welcomed.

All Abstract should:

- indicate the problems or issues the research addresses and relating it to the literature
- briefly outline the methodology used in the research
- provide indication of main findings to date
- include bibliographies.

Abstracts should be between 500 to 800 words in length (excluding bibliography).

- All abstracts should be prepared and written in **English using the ABSTRACT Conference Paper or Panel Template SUBMISSION FORM (see below to download forms)**
- Conference Papers and Panels will be organised in parallel sessions.
- Special Note on Panel Submissions: A panel submission is a proposal for a coordinated set of papers (usually 3 or 4 in number) on a particular topic or issue. Please note that panel proposals require an abstract identifying and justifying the theme of the panel as well as a full abstract for each panel paper. Panel proposals that do not include full abstracts and author information for each paper will not be considered. The person submitting the panel proposal must be willing to act as the panel coordinator and ensure that all proposed paper presenters commit to attending the conference. Please note that papers which are part of a submitted panel cannot be submitted separately as an individual submission. If the submission is submitted twice by the same author it will be rejected.
- Submissions by practitioners, emerging scholars, and Masters and doctoral students engaged in research are very welcome.
- All authors and presenters must formally register for the conference.
- ***Please note that you must submit your abstract online and must use our Paper or Panel ABSTRACT TEMPLATE for abstract submissions.*** To download the template:
