Applicants shall fit the following criteria to apply for the scholarship:

Applicant must be:

- An employee or immediate family of an employee of an ITRA Member in good standing.
- Enrolled in a two or four-year accredited college.

The completion of the application is the responsibility of the applicant. One scholarship will be awarded per year but past recipients may re-apply each year as they continue through a program.

Application Process

An application is enclosed for your convenience. If necessary, you may request additional applications from the ITRA office, or download the application from the web site: www.itra.us. Completed applications should be mailed in advance to the ITRA office where they will then be forwarded to the Scholarship Committee for review no later than February 26, 2020 for the 2021 Fall session. Interviews will be conducted if necessary and the successful candidate will be announced in April 2021. All other applicants will be notified by email. Funds for the scholarship will be dispersed directly to the educational institution ("Third Party Pay").
