Tenth Judicial District – Johnson County District Court 2018 Judicial Evaluation Results

1. Survey Overview

- The Johnson County Bar Association mailed surveys to 2,231 lawyers with registered offices in Johnson County.
- 303 surveys were returned and this quantity was well above the number needed to achieve a 95% confidence level with a 5% margin of error, which are research industry standards. Therefore, these results are considered representative of the surveyed population.
- Lawyers were asked to evaluate judges with whom they had personal experience.
- Survey data was kept confidential and managed by a third party.
