



Smart Start & JCBA - Paid Referral Program

The largest ignition interlock provider in the world “Smart Start” and The Johnson County Bar Association (JCBA) are partnering to create an exclusive “SS/JCBA Referral Program”. Just by referring JCBA clients to Smart Start, an attorney will receive a referral payment based on the number of clients that **install** a Smart Start ignition interlock device. (See below payment schedule) The funds will be paid monthly to the receiving entity designated. No payments can be made unless all documents are completed and returned to Smart Start prior to beginning Referral Program.

The process is simple. When a JCBA client **installs** a Smart Start ignition interlock; the attorney referral name will be logged by a Smart Start customer service representative and the referring attorney will receive payment. The payment will be submitted electronically once a month, specific to the number of clients that install with the attorney tracking name.

There are no contracts or agreements to sign, just provide the requested information and the referring attorney will begin receiving additional revenue each month for referrals **received and installed** by Smart Start.
