### KENTUCKY OUTSTANDING YOUNG LAWYER AWARD

The Kentucky Bar Association Young Lawyers Division seeks nominations for the 2019 Kentucky Outstanding Young Lawyer Award. The Award seeks to honor individuals who have excelled in three areas: 1) the practice of law; 2) service to the legal profession; and 3) community service. The Selection Committee will consider each of the three criteria listed above in determining the Award recipient.

To be eligible for the Award, a nominee must be:

- a) Admitted to the practice of law in Kentucky; and
- b) Forty years old or younger as of July 1, 2019 **or** have been admitted to the practice of law for ten or fewer years as of July 1, 2019.

A nominee need not be a member of the Kentucky Bar Association Young Lawyers Division.

To nominate an individual for the 2019 Kentucky Bar Association Outstanding Young Lawyer Award, please submit the following materials by **Friday, April 5, 2019**:

- a) Completed nomination form;
- b) Two recommendation letters discussing why the nominee is deserving of the Outstanding Young Lawyer Award; and
- c) Curriculum vitae or resume.
