A Note from Your ACEC-KY Executive Director, Russ Romine

Having started my tenure as executive director at the Kentucky Engineering Center on September 1st, I quickly got my feet wet with some of the issues and challenges facing consulting engineers. An issue of great importance to us, qualifications-based selection (QBS), was recently included in a Kentucky Administration Regulation (KAR) change proposed by the Kentucky Transportation Cabinet (KYTC). The change would have repealed three existing administrative regulations associated with QBS that have been in place for several years. Specifically, 600 KAR 6:020, 6:030, and 6:060 were included in the "repealer" regulation, 600 KAR 6:061. Although KYTC was not directly targeting QBS through this action, the removal of these regulations caused great concern and would have made future changes to the QBS process much more difficult to track. Fortunately, KYTC heard our concerns and withdrew their repeal. We were pleased to have ACEC National and NSPE join us in our effort to emphasize the importance of this issue. Both organizations wrote letters thanking the Transportation Cabinet for withdrawal of the repeal request, and highlighted the need to retain the regulations. We value the relationship and partnership we have with KYTC and look forward to opportunities that will strengthen that relationship going forward.

Speaking of partnerships, as highlighted below, ACEC-KY recently participated in the 21st Annual Partnering Conference. As you know, the Partnering Conference has long been an opportunity for our members to join with the Transportation Cabinet and the Federal Highway Administration (FHWA) to discuss the latest issues and nurture a partnership that brings value to all who participate. This year we had representatives from 37 ACEC-KY member firms who were joined by over 330 KYTC and FHWA employees to discuss topics ranging from Project Prioritization to Electronic Tolling. The two-day conference concluded with insightful messages from KYTC Secretary Greg Thomas and FHWA Kentucky Division

Administrator Thomas Nelson.

As September comes to a close and temperatures begin to fall, activities at the Kentucky Engineering Center are on the rise. We look forward to this year's installment of "seminar days" as we travel across the Commonwealth, bringing training opportunities to a meeting place near you. We are also excited to kick-off the 19th edition of Leadership P.E. which provides in-depth training and leadership development for entry and mid-to-upper level engineers. Transportation Cabinet to file P3 Regs

As prescribed in HB 309 – the "P3 bill" that passed during the 2016 Regular Session of the General Assembly – the Kentucky Transportation Cabinet (KYTC) has been developing Administrative Regulations that will detail the procurement approach and proposal review process that will be used for public private partnerships. KYTC will be filing the first set of regulations by October 15, with regulations regarding unsolicited proposals to be filed later. A review/comment period will be provided. ACEC-KY's Transportation Steering Committee continues to communicate with KYTC's State Highway Engineer's Office and monitor the progress. We will provide future updates as they are available.

KYTC, FHWA, and consultants with eight different tracks




