Tax Information for Your Dues

While LCPA dues payments are not tax deductible as charitable contributions, they may be deductible as ordinary and necessary business expenses or under other provisions of the IRS Code, subject to restrictions imposed as a result of association lobbying activities. LCPA estimates the non-deductible portion of your 2019 dues allocable to lobbying is 10%.
