1. Large Community/Group Rate = \$1,500 member/\$1,750 non-member– early bird rate

For those communities with 6 or more employees, we are offering you the opportunity to register for one group/community rate of \$1,500. This allows you an UNLIMITED number of registrants for this rate. Sign up as many attendees as you would like for ONE PRICE. Register your Directors of Nursing, Nurses, Finance/Accounting Staff, Human Resources Staff, Nursing Home Administrators, Sales and Marketing Staff, Technology Staff and Maintenance Staff! Housing Members can register your Managers, Service Coordinators and Maintenance Staff! There are over 60 sessions to choose from, plus the exhibit hall, Keynote Speakers, Membership Awards Program and networking events.

Each attendee MUST have a unique registration in order to participate in the Virtual Convention.

2. Small Community/Individual Rate = \$349 individual member/\$449 individual non-member – early bird rate

For those communities with 5 or fewer employees, we are offering you an affordable individual rate of \$349 per person. This option was designed to help you save by paying for only the number of people who are able to participate in the event. All sessions, Keynote Speakers, exhibit hall, Keynote Speakers, Membership Awards and networking events are included.

Each attendee MUST have a unique registration in order to participate in the Virtual Convention.

3. Business/Vendor Individual = \$2,000 member/\$2,250 non-member – early bird rate

This category is for Business member employees who are not exhibiting in the 2020 Virtual Convention Exposition. *Each business employee in this category must have a unique and separate registration record. Business Vendors are not eligible for group or community rates.*

4. Residents/Retirees/Students = Complimentary Registration

This category is for current residents of a member community or retired former members of LeadingAge Florida. This is also being extended to current students in healthcare fields with a current/valid student ID. Members of this category are able to register for free, compliments of the Membership and Association.

Each attendee **MUST** have a unique registration in order to participate in the Virtual Convention.


If you have not yet registered and are seeking the GROUP rate, we suggest you select one point person for your organization to register any staff on your team. This will ensure you are charged only one group rate per organization, as opposed to multiple registrants being charged the group rate.

The point person should collect the names, job titles and emails of the people wishing to register. Once that person logs into the LeadingAge Florida website, they may register the initial person for the flat fee, and then “Save & Add Another Attendee” to keep adding registrants until finished. Once all staff have been added, click “Save & Finalize Registration.”




If you wish to add additional registrants at a later time, you may do that, too!

- Log into the LeadingAge Florida website and Click “Manage Profile”
- Then click “Event Registrations”
