Application Components

1. **Application Process** - This program is only available to individuals employed with a LeadingAge Florida member community. Reminder, only one applicant per community will be considered. If a Fellow's employment status changes or if he or she fails to meet any of the program's eligibility criteria, continued participation in the Leadership Academy is subject to review by LeadingAge Florida. Please submit the statement of commitment, a letter of reference, resume or short biographical summary and leadership essay no later than 5:00pm on July 10, 2020. Completed applications can be emailed to Mmaggio@LeadingAgeFlorida.org. Provide contact and organization information.

2. **Statement of Commitment** - Applicants are required to submit a Statement of Commitment (next page) signed by their sponsoring organization.

3. **One Letter of Professional Reference**
Applicants are required to provide one professional letter of reference.

4. **Resume or Biography**
Applicants are required to submit an updated resume clearly indicating their current position, responsibilities and accomplishments or a short biographical summary reflecting the same points.

5. **Leadership Essay**
Please complete your personal leadership essay using the following points as headers. Please make sure you provide enough information to give the selection committee insight into your history and desire to be part of this program. One or two sentence answers to the following questions are not recommended. Please limit your responses for all three topics to one page.

- What attributes do you feel an effective leader should possess and how would your participation in the Leadership Academy strengthen you as a leader? Please refer to a significant professional achievement, your specific role in attaining that achievement and the impact it had on your organization.
- What do you view as one of the current gaps in aging services? Coupled with your academy experience, what role might you play in addressing the gap?
- Describe your personal commitment to aging services and how you envision using your experience to enhance aging services within your organization, your community and at the state and national levels.

Evaluation Criteria

All application submissions will be reviewed to ultimately assemble a diverse class of LeadingAge Florida Leadership Academy Fellows (in terms of life experiences, leadership roles, geography, type of organization, as well as other unique characteristics). A committee of LeadingAge Florida member leaders will evaluate applications using the following criteria:

- How strongly defined, insightful and introspective is the leadership essay?
- How strongly does the applicant demonstrate a personal commitment to the field of aging services?
- How strongly does the applicant demonstrate a dedication to life-long learning?
- To what extent does the applicant possess the leadership capacity needed to become a transformational leader?
