OVERVIEW

This program has been developed for our LHA members only and will cover the newly implemented Medicaid Managed Care Independent Review program resulting from Act 349 of the 2017 Session. This legislation created a simplified and standardized process that providers could access in disputing Medicaid MCO claim denials. This program focuses on the mechanics of the Independent Review process, including the steps, timelines involved and responsibilities of all parties. Additionally, the presenters will cover how to appropriately and effectively utilize the process while meeting the requirements and improving odds for success.
