OVERVIEW:

What is medication for addiction treatment (MAT)? This webinar will provide a comprehensive and thought-provoking crash course in emergency department (ED) MAT. Dr. Stader will begin with a discussion of opioid use disorder (OUD) as a fatal and misunderstood disease, challenging preconceptions and giving providers a deeper understanding of addiction.

The webinar presenter will describe how EDs can implement evidence-based practices to treat OUDs, and how these therapies can improve the lives and outcomes of patients with OUDs.

Dr. Stader will walk through program logistics of how to initiate buprenorphine in the ED and will facilitate discussion of implementation protocols as published on www.ColoradoMAT.org.

ColoradoMAT functions as a guide for ED administrators and frontline clinicians to start an ED MAT program in their own facilities.

OBJECTIVES:

Upon completion of this program, participants will be able to:

- Describe the opioid epidemic and its impact on practices, communities and country;
- Provide a better understanding of OUDs and addiction;
- Illustrate the compelling science behind MAT and buprenorphine;
- Describe the laws pertaining to buprenorphine and how they apply to clinicians; and
- Discuss how providers can apply MAT in practice.
