#### APRIL 20 CODE ENFORCEMENT MTI (VIRTUAL); 1:30 - 4p.m.

Blight and nuisances are a continual point of conversation and frustration for many cities around the state. Within our cities, code enforcement is used to resolve health, safety, and public nuisance problems that may adversely affect the quality of life for citizens. In this MTI, we will explore the legal authority cities have when responding to code complaints and nuisances. We will review the process of code enforcement and discuss best practices for cities to use when addressing property maintenance and blight in their communities.
